- Recruiting GAs (Top 10 qualify) ... \$1,000,000 min. production
- Agents \$200,000 min. production

Complementary Products only –

• Agents (Top 10 qualify) \$200,000 min. production

Final Expense only –

• Agents (Top 10 qualify) \$200,000 min. production

#### **QUALIFYING PRODUCTS:**

- Medicare Supplement = one for one on production
- Complementary Products = two for one on production (Cancer Plus, Continental Care, Home Care, Nursing Facility Care)
- Final Expense = two for one on production
