## **MEETING ROUNDUP**

Our February meeting – the second of our annual Forensics Fest meetings – was marked by a pair of memorable speakers. **David Putnam** discussed his journey from law enforcement to writing. **Richard Rodriguez,** of the O.C. Sheriff-Coroner Dept., gave a vivid (and not for the squeamish) PowerPoint presentation about the agency and some of its investigations.

During his more than thirty years in law enforcement Putnam was an officer with the Sheriff's Department in Ontario, South Central Los Angeles, and San Bernardino. He also worked out of Hawaii as a special agent, working on white collar crime and smuggling.

He recounted some of his cases, which involved bank robbers (one known as "the handsome bank robber"), gang members, meth dealers and other nefarious types. It was while working surveillance — "there was quite a bit of down time" — that he read mystery and crime books, and realized that many authors weren't authoritative about their subjects. "I got to thinking that I could do better," said Putnam. After all, he explained, "writing police reports is a lot like writing short stories."

His earliest books were written in longhand on legal pads; he wrote numerous books before he managed to sell his 2014 title, *The Disposables* (Oceanview Publishing) about an ex-cop who is also an ex-con. *Publishers Weekly* called it "a fast-paced tale of idealism and corruption." The recent follow-up, *The Replacements*, has also garnered strong reviews; *Publishers Weekly* noted, "Putnam steadily ratchets up the tension while memorable supporting characters … help engage reader interest."

Rodriguez, who is Chief Training Officer for the Coroner Division, discussed the agency's workings and their responsibility. "We're here to protect the deceased. To give them a voice," he said. The coroner determines the mode, manner and cause of death. The different types of death are: homicide, suicide, accident, natural and undetermined. Rodriguez talked about various investigations and how determinations were made.

His talk included plenty of information for authors to consider. Did you know that a dead body can still tan? Or that it takes eight weeks for a body to decompose in the ground, compared to one week in the air and two weeks in the water? Now you do.
