HERS certificate summary sheet(s) is required only if applying for the Adoption of the Citizens Gas/ IPL Silver Star, Gold Star Programs or the ENERGY STAR Version 2.5 Standards Incentive.
- 4. Equipment must be purchased and HERS certifications must be completed on or after April 1, 2011 for the Citizens Gas/ IPL Silver Star, Gold Star or ENERGY STAR 2.5 Programs.

- \* If rebates total more than \$600 in a calendar year, Citizens Gas/ IPL is required by law to provide appropriate tax forms to the builder.
- \*\* Energy Factor (EF) is the overall efficiency rating for water heaters. Beginning May 1, 2011 Citizens Gas will offer a \$150 rebate for natural gas storage water heaters that hold 30 gallons or more for all new homes with an EF ≥ 0.67 and a \$50 rebate for water heaters with an energy factor (EF) between 0.62 and 0.66.
- \*\*\* Beginning April 1, 2011, homes must have either the equivalent of Version 2.0 HERS score of ≤ 85 to meet Citizens Gas/ IPL's Silver Star Program Standard or the HERS equivalent score of ≤ 70 to meet Citizens Gas/ IPL's Gold Star Program Standards and meet all the ENERGY STAR Thermal Bypass Requirements. For natural gas heated homes within Citizens Gas and IPL service territories, homes must have a ≥ 92% AFUE natural gas furnace or a ≥ 90% AFUE natural gas boiler and a ≥ 0.62 EF natural gas water heater or, or an 88% AFUE for a 75 gallon water heater or a ≥ 0.82 EF tankless water heater. Builder may also apply for these individual equipment/product rebates in addition to the Silver Star, Gold Star or ENERGY STAR rebates. Homes permitted on or after April 1, 2011 must meet all the specifications and requirements for Version 2.5 ENERGY STAR qualified homes to obtain an ENERGY STAR certification.

I certify that I have purchased the product(s) and/or service(s) indicated on this form, and the product(s) was/were installed at the address indicated. I understand that random inspections may be conducted to verify installation according to the terms and conditions. I have read and understand the general eligibility, terms and conditions associated with this program. **General Eligibility:** This offer provides rebates for achieving specific HERS Index rating. Offer valid for home builders constructing new homes in the Citizens Gas/ IPL's service territory. The New Construction Rebates on this form are available for single-family homes and multi-family dwellings of up to 12 attached units per development. Citizens Gas Westfield customers not eligible for this program.

Dual fuel heating systems are not eligible for the Citizens Gas/ IPL natural gas new construction rebates for the Citizens Gas/ IPL Silver Star, Gold Star and ENERGY STAR Programs.

All builders/applicants must complete a W-9 to receive a rebate.

**Verification:** Citizens Gas and IPL reserve the right to verify sales receipts and/or installations of products and services and that the equipment installed must meet program requirements before issuing rebates. A random inspection may be conducted to verify installations. Citizens Gas and IPL shall require a copy of the HERS Certificate for all Citizens Gas/ IPL Silver Star, Gold Star and ENERGY STAR Programs.

**Program Modifications:** Citizens Gas and IPL reserve the right to alter or discontinue these rebate offers at any time without notice. Rebate funds are limited and are available on a first-come, first-served basis.

Citizens Gas and IPL reserve the right to alter or discontinue this program or related rebates at any time without notice.

## 2011 PROGRAM MODIFICATIONS AND CHANGES:

Starting April 1, 2011 the EPA's ENERGY STAR New Construction Program will require all new homes permitted after April 1, 2011 to meet the guidelines for **Version 2.5 ENERGY STAR qualified home certification**. The new specifications for Version 2.5 are much more stringent than Version 2.0 which is in use through March 31, 2011. Homes permitted prior to April 1, 2011 and completed by December 31, 2011 may qualify for Version 2.0 for ENERGY STAR Certification. Contact your Rater/Provider or go to www.energystar.gov for more details about Version 2.5 ENERGY STAR qualified homes.

Citizens Gas/ IPL Silver Star Program: Beginning April 1, 2011 Citizens Gas and IPL will offer a Silver Star Program Rebate for all homes permitted after April 1, 2011 that meet the equivalent of Version 2.0 HERS Index of < 85 until Indiana implements the equivalent of the 2009 International Energy Conservation Code (IECC).

The Citizens Gas/ IPL Silver Star homes cannot be considered as ENERGY STAR Certified Homes.

Citizens Gas/ IPL Gold Star Program: Beginning April 1, 2011 Citizens Gas and IPL will offer a Gold Star Program rebate for all new homes permitted after April 1, 2011 that meet the equivalent of Version 2.0 HERS Index of < 70 until Indiana implements the equivalent of the 2009 International Energy Conservation Code (IECC).

The Citizens Gas/ IPL Gold Star homes cannot be considered as ENERGY STAR Certified Homes.

**Drain Water Heat Recovery System (DWHR):** Citizens Gas and IPL will offer a limited number Rebates for the Drain Water Recovery System installed for new homes. Copper coils and drainpipes must be lead free and double wall construction. The following are approved manufacturers of DWHR Systems: Renewability, ReTherm Energy Systems, and Watercycles Energy Recovery, Inc.
