- (i) Majority consent (60%) of landowners for dereservation if land is within iTaukei reserve.
- (j) Application fees of \$115.00 (Comm/Ind), \$575.00 (Tourism) & \$115 (Eco-Tourism) and \$57.50 for Residential leases.

- (k) Investment Fiji Requirements (RBF Clearance) & Evidence of Foreign Investment Registration Certificate.
- (I) Department of Immigration Approval.

- (n) Locality Plan of area applied for Feasibility Study (where applicable).
