Mrs. Marilyn Brown was able to maintain this equilibrium in a professional and dedicated manner over a period of 20 years. Mrs. Brown was a member of the core group around which the financial aid program at Montgomery College was formed and coalesced over the years. She also played a major part in the mentoring of the program as it exists today.

- 3. Professional ethics of the highest caliber.
- 4. Work and contributions above and beyond the call of duty to the student, the school, and/or the professional association.
