This is your invitation to become both a Certified Ericksonian Hypnosis Instructor and a Certified Neuro-Linguistic Programming (NLP) Trainer.

During the last few years participants have frequently asked to become certified trainers of both Ericksonian Hypnosis and NLP. As a result, I have designed a training program to give you the opportunity to become both a **Certified NLP Trainer and an Ericksonian Hypnosis Instructor**.

I've been training mental health professionals in both of these approaches for the past 30 years. Now, I want to share what I've learned with a very small group of highly motivated people. Further, I hope that by offering this program you will carry on the legacy of excellence of the American Hypnosis Training Academy by providing training to your future seminar participants.

The class will be limited to 12 participants to assure maximum learning and plenty of individual coaching from me. Additionally, after the end of this training, I plan to provide ongoing mentor/coaching on course design, marketing, business planning, running your training business, and building a following of satisfied graduates.

The Skills You Will Learn:

- Teaching to the conscious and unconscious mind
- Creating and maintaining the desired states in your students
- Working with the group process, common challenges and solutions
- Gaining group rapport and holding the participant's attention
- Developing and maintaining your personal training state of excellence
- Creating effective stage anchors
- Integrating content for effective presentations
- Using multi-embedded metaphors
- Demonstrating content as you teach (walk the talk)
- Utilizing your physiology and language to empower your teaching
- Conducting successful demonstrations and how to select subjects
- Making content much more learnable by the use of pre-framing
- The importance of appropriate sequencing of the material being taught
- Utilizing and handling objections, questions, and "hecklers"
- Giving effective feedback

This dual certification training will be a highly structured and rewarding experience. Additionally, each participant will receive the following materials:

- **Course Curriculum/Manual**

Instructor's course outline/manual with a complete set of handouts that can be duplicated for your students. Additions to these material will be forwarded periodically, as they become available. **Note:** You may use your own headings for these handouts, however, *handouts must maintain their copyrights and identifying information, as printed on the copies you receive, whenever you reproduce them. Your students must agree in writing not to further duplicate them.*

- **Videos**

One set of videos is included in your tuition. These videos are copyright protected and may not be reproduced. You will be given permission to use the videos intact, with the copyrights, for your personal use and demonstration purposes during your professional workshops and training programs. - **Affiliation with AHTA for Continuing Education Approval**

Ongoing affiliation with Ron Klein and AHTA for continuing education approval can be negotiated separately by those persons who are certified at the completion of this program. The American Hypnosis Training Academy, Inc. (AHTA) continuing education approval, granted by the American Psychological Association (APA), the National Association of Social Workers (NASW), and the National Board of Certified Counselors (NBCC), can only accrue to workshops and training programs sponsored, co-sponsored, and/or administered by AHTA. Affiliation with AHTA or Ron Klein, for this purpose, is not guaranteed.

Upon completion of the Train the Trainer program each participant will complete the following post-training requirements:

- Review of the Ericksonian, traditional hypnosis and NLP literature as evidenced by completion of both the written research and exams, including three book reports. These materials must be submitted within 90 days of the last day of the training.
- Presentation of a two, three-day workshop or a longer training program within 6 months of the completion of the training. 3 hours of your presentation must be videotaped and submitted for review. The video tapes must include at least one lecture, a demonstration, an assignment of an experiential practice by students and post student practice Q&A.

The fee for reviewing these tapes by the instructor(s) of this program is \$450.00. This amount will be due when the tapes are submitted.

- Submission of written evaluations by the students who attend your two or three-day workshop or the longer training program (evaluation form will be provided by AHTA) indicating positive critique.

Once you've completed the above requirements, and have demonstrated satisfactory competency, you will be certificated as a **Certified NLP Trainer and an Ericksonian Hypnosis Instructor.**

Certification as a NLP Trainer and an Ericksonian Hypnosis Instructor will be earned upon satisfactory completion of the Trainer Training. Additionally, a certificate of attendance for 45 hours professional **CONTINUING EDUCATION** (C.E.) will be provided for those persons who complete the program. The American Hypnosis Training Academy (AHTA) is approved by the American Psychological Association to sponsor continuing education for Psychologists. American Hypnosis Training Academy maintains responsibility for the program and its content. AHTA is also an approved provider for NBCC, NASW, NADAAC AND VARIOUS STATE BOARDS details on request.
