- Infertility treatment
- Intercranial doppler
- Joint replacement
- Mammograms/Pap smears
- Maternity
- Medications (including birth control)
- Pediatrics
- Pelvic health and rehabilitation services
- PET scans
- Routine/Preventative/Screening Services
- Tubal ligation/Vasectomy
- The Center for Wound Healing at FHN

Any service or treatment not deemed as medically necessary under Title XVII of the Federal Social Security Act will also be considered an excluded service.

# Do you need help paying for medical care received at FHN?

If you do, we'd like to help. Our mission includes providing necessary healthcare to the people in the FHN service area who may be experiencing hardship (our service area is defined on the back of this brochure). To fulfill this commitment, the FHN Assisted Care Program provides financial assistance to those who meet geographic, income and financial requirements (based on family size), as well as a six month residency requirement.

#### What is FHN Assisted Care?

It is a financial assistance program that can help those who qualify reduce their FHN medical bills.

## How do I apply?

You may apply for FHN Assisted Care at any FHN location. To be considered for the program, you must complete an application. Including:

- Number of household members
- Income and assets (such as savings and real estate).

#### Your responsibility

- Depending on your eligibility level, you will be required to make a copayment for each service and in some cases, a percentage of the charges.
  Your co-payment(s) will be required at the time of service.
- In order to receive care from a specialist, you must receive an approved referral. If you do not have a referral, you must pay for the visit.
- Some procedures must be pre-certified in order to qualify. See the list in this brochure. Precertification must be completed by you or your provider by contacting Northern Illinois Health Plan at 1-800-723-0202 (option 3).
- If you are approved for FHN Assisted Care and need to continue utilizing the program, you will be required to reapply every six months.



#### Which services are covered?

- Physician office visits
- Tests
- Urgent or emergency care
- Medically necessary hospital services



### Where is care provided?

If you live in Freeport, Cedarville, Pearl City or Scioto Mills zip codes and do not have Medicare or any other insurance, you must receive primary healthcare through the FHN Community Healthcare Center, located at 10 West Linden St., Freeport, IL. To make an appointment, please call 1-815-599-8414.

If you live in a surrounding community other than those mentioned above, you must receive primary healthcare services at the closest FHN Family Healthcare Center or at the FHN Community Healthcare Center in Freeport.
