**DECLARATION OF MALERIE MAGGIO IN SUPPORT OF
PLAINTIFF'S THIRD *EX PARTE* APPLICATION FOR ENTRY OF
TEMPORARY RESTRAINING ORDER AND PRELIMINARY INJUNCTION**

I, Malerie Maggio, declare as follows:

1. I am over 18 years of age and have personal knowledge of the facts set forth herein. I make this declaration in support of Plaintiff's Third *Ex Parte* Application for Entry of Temporary Restraining Order and Preliminary Injunction (the "Application for TRO").
2. I am an employee of Investigative Consultants, a licensed private investigative firm.
3. Counsel for Plaintiff, Abercrombie & Fitch Trading Co. ("Abercrombie") retained my firm to investigate the suspected sale of counterfeit Abercrombie products by Defendants, the Partnerships and Unincorporated Associations Identified on Schedule "A" attached to Abercrombie's Application for TRO (the "Defendants").
4. I accessed the Internet websites operating under the Defendants' domain names identified in the table below. Upon accessing each website, I was able to browse each online store for products bearing Abercrombie trademarks, add products to the online shopping carts,

proceed to a point of checkout on each website, and otherwise actively exchange data with each website. I then placed an order via each website for the purchase of an Abercrombie branded product as detailed in the below chart, each to be shipped to my address in Miami, Florida. Each of my purchases was processed entirely online, which included providing shipping and billing information, payment, and confirmation of each order:

Thereafter, true and correct copies of redacted excerpts of the websites listed above, reflecting the items I purchased, including images, were provided to Brandon Scott at Abercrombie for his review and analysis.

I declare under penalty of perjury under the laws of the United States of America that the foregoing is true and correct. Executed the 20th day of April, 2012, at Torrance, CA.



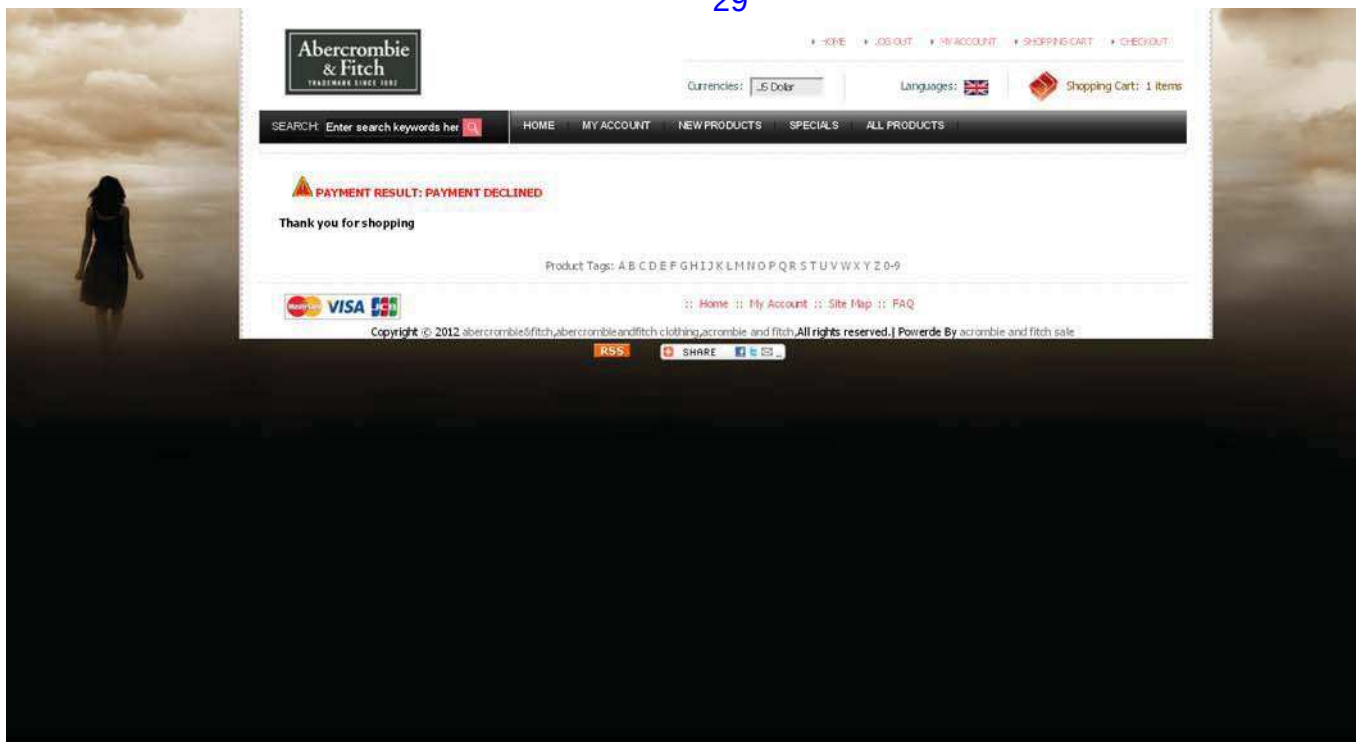
