Background Information

Background Information



- Based on the Default Service Plan approved by the Pennsylvania Public Utility Commission ("Commission"), DLC conducts a competitive RFP process to acquire default supplies for Residential, Medium and Small C&I customers
- Solicitation is for full requirements load following service
 - Requires energy, ancillary services, capacity, alternative energy credits, losses and other items listed in the SMA
 - The amount of energy and other services and products a supplier must provide will vary depending upon DLC's actual default service load
- The procurement amount in each customer class is divided into blocks of equal size
 - Load served within each block will increase or decrease proportionally with the other blocks to achieve the supply needed to meet load.
- Delivery is to the Duquesne Residual Aggregate Zone in PJM

Background Information (continued)

- DLC utilizes relevant bid documents specific to the Commission approved POLR VII plan for ALL POLR VII solicitations
- If for any reason an RFP fails to attract a sufficient volume of bids, the Commission does not approve the submitted bids, or an accepted supplier defaults, DLC will meet its default supply obligation on an interim basis through purchases in the PJM spot market and will be permitted to recover all of the costs of such purchases and reasonable administrative costs from Default Service Customers. DLC will submit to the Commission within 15 days after any such occurrence, a contingency plan to handle any default service shortfall.

- Release of weighted average of winning bids, separately by class, within 2 business days after execution of the contracts



RFP Process Details





Supply Requirement Overview

- The current solicitation seeks proposals for default supply for Residential & Lighting,
 Small Commercial & Industrial (C&I) and Medium C&I Customers:
 - Residential and Lighting Offered in 12 blocks for 50% of supply requirements for delivery period 12/1/2016 – 11/30/2017
 - Small C&I Offered in 2 blocks for 50% of supply requirements for delivery period 12/1/2016 11/30/2017
 - Medium C&I Offered in 4 blocks for 100% of supply requirements for delivery period 12/1/2016 2/28/2017
- Pursuant to the Commission's Order, no one supplier may procure more than 50% of the load for the Small C&I and the Residential and Lighting classes for this delivery period
- A single supplier can procure 100% of the Medium C&I class for this delivery period

Pace Global Responsibilities Independent Market Monitor



- We are the liaison between the potential bidders and DLC
- We answer all the questions regarding the solicitation process
 - Questions and correspondence can be sent to Pace Global by email to ICUSBTPaceDuquesneRFP.Industry@siemens.com
- We conduct and monitor the RFP process
 - Bids can be submitted through the Procurex bidding interface
 - Up to 6 bids may be submitted by any bidder for the Residential & Lighting blocks (50% of the available blocks)
 - Up to 1 bid may be submitted by any bidder for the Small C&I blocks (50% of the available blocks)
 - Up to 4 bids may be submitted by any bidder for the Medium C&I blocks (100% of the available blocks)
- We review all bids and associated paperwork for compliance and conformity
- Only Pace Global and the Commission have discretion to reject bids
- We review any disputes or selection decisions for resolution
- We maintain the security at the bid site DLC does not see bid results until after close of bidding
- We summarize the results along with a certification of compliance with all requirements and security

DLC Responsibilities



- Signs the Non-Disclosure Agreement (NDA)
- Reviews and approves all financial qualifications
- Provides Pace Global with answers to all questions (posted on the web site and / or sent to bidders)
- Cooperates with bidders and provides relevant information
- Verifies that bidders are qualified with PJM to provide the services
- Signs the SMA
- Works with Pace Global to address any conflicts or disputes
- Manages the contracts in accordance with the SMA
- Works with PJM and winning bidders to properly allocate charges per the SMA
- Releases the weighted average of all winning bids for all solicitations, (not individual bid prices or supplier names), within 2 business days after execution of all contracts and publishes the revised retail rates 45 days before they become effective

Supplier Eligibility Criteria



- PJM qualification and FERC authorization
 - Must be a qualified market supplier in good standing with PJM
 - Must have FERC authorization to make sales of energy, capacity and ancillary services at market based rates
- Express interest by requesting a username and password via Procurement web site
- Execute the Non-Disclosure Agreement (NDA)
 - If you have an executed NDA from either the March 2015 RFP, June 2015 RFP, September 2015 RFP, December 2015 RFP, March 2016 RFP or the June 2016 RFP, this will carry through the end of the POLR VII solicitations
- Submit financial information through a credit application
- Conform with bidding requirements
- Upon notification of a winning bid, submit a Binding SMA at completion of bidding
- Submit the credit application and NDA, place bids, sign the SMA and serve the load in PJM all under the same legal entity

Bid Submission Process



- All bids must be submitted:
 - On the bid day that is set September 13, 2016
 - Through the secure Procurex website's bidding interface
 - Using the appropriate Bid Form on the website
- All bids can be rescinded and/or reviewed via the bid interface. Bidders' individual login and password is required to submit, rescind, or review bid
- All fields within the Bid Form require that the supplier's input must be completed in order for the bid to be conforming
- An e-mail will be automatically sent to the bidder indicating that the bid has been received
- Bids may be sent by FAX as a contingency if there is a problem with the electronic system. FAX
 Number 1-844-806-8411. If a fax is used, Pace Global must be alerted by telephone to this change in

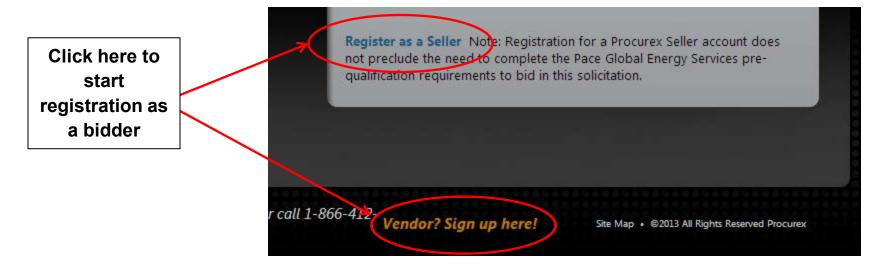
- The SMA is included on the Procurex web site for review

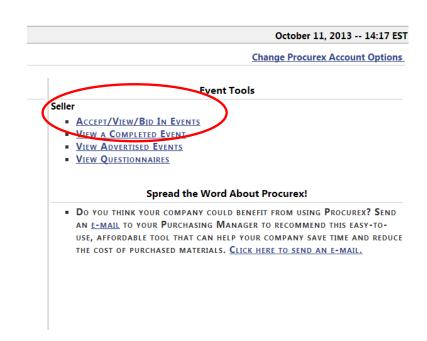

- After logging in, you can select the "Accept / View / Bid In Events" link

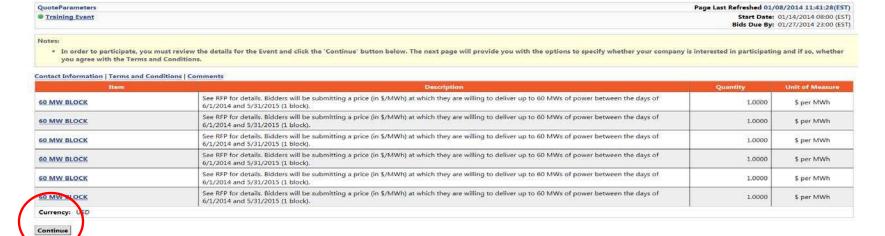


Event Screen

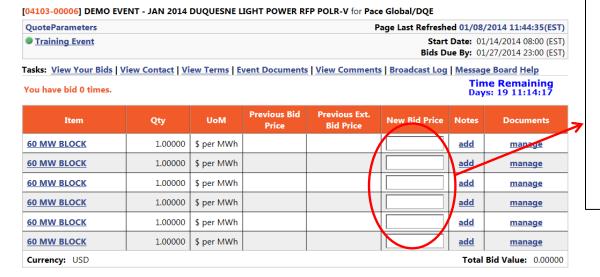

Placing bids



The bidding interface is shown below



You are not required to bid on all blocks. For blocks you do not intend to bid on, leave the Bid Price field blank. You can choose to bid on all or some of the blocks.

Preview Bid Reset Close

- After placing a bid, the Previous Bid Price and Previous Ext. Bid Price fields reflect what you entered (these fields are identical). Bids can be changed by submitting a new bid
- Notes can be attached to bids which are visible to Pace Global

Evaluation of Bids

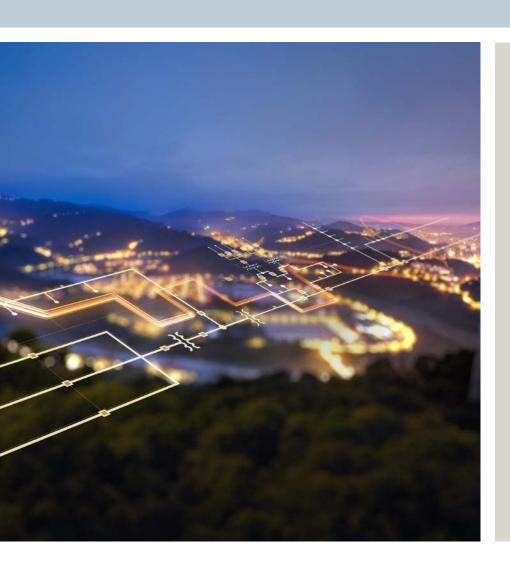
Evaluation Criteria



- Conforming bids must be submitted:
 - using the Procurex bidding interface
 - by the due date and time
 - by an eligible supplier
- **Evaluation of Bids**
 - The single price bid for a given block is the parameter used to compare all offers within the same service type and the same contract term
 - Bids are ranked by price and the lowest bidders are chosen
 - Tie breaking between 2 identical bids are based on the bid that was received first
 - Winning suppliers are paid their offer prices pursuant to contract
 - All bids submitted are kept confidential, in accordance with the NDA, although aggregate prices of winning bids are released
 - DLC does not see bid results until after the close of bidding
