Tax Information Sheet

When verifying your FAFSA, we may be required to review your tax returns. Not sure if you are required to file taxes? Use the calculator on the IRS website <u>http://www.irs.gov/uac/Do-I-Need-to-File-a-Tax-Return</u>?.

To document your tax return, you may do one of the following:

- Use the IRS Data Retrieval Tool to transfer tax data to your FAFSA , OR
- Provide an IRS Tax Return Transcript

IRS Data Retrieval Tool

If you did not use the IRS Data Retrieval Tool when you filed your FAFSA, you may still do so.

- 1. Login at fafsa.gov to "Make FAFSA Corrections"
- 2. On the FAFSA, in the Financial Information section, click "Link to IRS"
- 3. On the IRS website, fill out the form and click on "Transfer my tax information into the FAFSA"

You will be unable to use IRS Data Retrieval Tool if:

- Your marital status changed after December 31
- You filed an amended return (See Tax Transcript below)
- You filed married filing separately
- You filed a tax return using a Tax ID Number (TIN)
- You filed a foreign tax return Submit a signed copy of your return to the financial aid office
- The home address on the FAFSA does not match the address on the tax return

Note: Tax information electronically filed within the last 2 weeks or submitted by mail within the last 8 weeks may not be available.

IRS Tax Transcript

If you are selected for verification of your FAFSA, and are unable to use the IRS Data Retrieval Tool, you must submit an official <u>IRS TAX RETURN TRANSCRIPT</u>, (not an Account Transcript.) There are multiple ways to do this:

Request a transcript electronically on the IRS website at http://www.irs.gov/Individuals/Get-Transcript

• If you filed an Amended Return:

- o Submit both an IRS Tax "Return Transcript" and an IRS Tax "Account Transcript," OR
- Submit the Record of Account, (using IRS Form <u>4506-T</u>), which could take up to 30 days
