Dog Playgroup Agreement

I, _____, the undersigned owner of a dog named _____, do hereby release, indemnify and forever hold harmless Blue Dingo Dog Ranch LLC, a Washington Limited Liability Corporation, its employees, officers, investors, agents, subcontractors, customers, visitors, volunteers, property owners, and associates from any and all liability (including attorney's fees) and claims or damages arising out of or connected with injuries, illness, loss, damage or other harm to myself, my dog, my property, and my guests and invitees, mild or severe, which arise in any way out of services and/or products provided by or as a consequence of my association with Blue Dingo Dog Ranch LLC.

I acknowledge that dogs are unpredictable in behavior, and I understand that injuries to my dog, my guests, and myself might reasonably be foreseen to result from my dog's attendance and participation with Blue Dingo Dog Ranch LLC. I am fully aware that Blue Dingo Dog Ranch LLC encourages off-leash socialization and interaction of dogs in its custody and care and accordingly I assume any and all risks related to Blue Dingo Dog Ranch LLC's performance of its services, including but not limited to bites, bodily injury, damages, claims, and expenses that may occur as a result of my dog's actions.

I authorize Blue Dingo Dog Ranch LLC to contact my veterinarian in order to confirm health, temperament and vaccinations. If, in my absence, my dog should be injured, become ill or suffer an ailment or is otherwise deemed by Blue Dingo Dog Ranch LLC to require immediate medical attention, Blue Dingo Dog Ranch LLC is authorized to utilize the services of my veterinarian or another licensed veterinarian if Blue Dingo Dog Ranch LLC determines that this is necessary for any reason. Blue Dingo Dog Ranch LLC, in its sole discretion, is authorized to make all health care decisions on my behalf, and may utilize the services of a licensed veterinarian to administer medicine or give other requisite attention to my dog. I understand that I shall be responsible for any and all charges with respect to such veterinary care. Further, should I be required to take my dog to a veterinarian after an excursion or visit with Blue Dingo Dog Ranch LLC, I shall be responsible for any and all veterinary or other related or unrelated charges; Blue Dingo Dog Ranch LLC shall in no way be responsible for the same. I hereby indemnify Blue Dingo Dog Ranch LLC from any action, claim, demand or lawsuit (including attorney's fees) arising out of or connected with the charges made by any veterinarian caring for my dog.

I hereby certify and represent that my dog is in good health and has not been ill with any communicable condition in the last 30 days. I also represent that my dog is current on its vaccinations for Rabies, Bordetella, and DHLPP. I further certify that my dog has not harmed or shown aggressive or threatening behavior towards any person or any dog or animal. I understand that Blue Dingo Dog Ranch LLC reserves the right to refuse service for any reason at any time. I certify and represent that all of the information provided to Blue Dingo Dog Ranch LLC in writing or otherwise relating to myself and to my dog is true and correct.
