



## MINOR MODEL RELEASE AGREEMENT

This Minor Model Release Agreement, hereinafter referred to as the "Agreement", is between The Focused Lens, L.L.C., referred to as the "Photographer", and a minor (under the age of 18) photographic subject of this photography agreement, hereinafter referred to as the "Minor Model", and the legal guardian of the Minor Model, hereinafter referred to as the "Guardian", collectively referred to as the "Parties", with the portrait session detailed below.

I, the below signed Guardian, hereby assign full copyright of these photographs to The Focused Lens, L.L.C., and the related representatives and their assignees, together with the right of reproduction either wholly or in part.

I grant to the Photographer or licensees or assignees the permission to use the above-mentioned photographs either separately or together, either wholly or in part, the perpetual, irrevocable and unrestricted right to use and publish video and/or photographs of the Minor Model, where it may be included for editorial trade, general marketing, product advertising, fashion and any other business purpose in any manner and medium.

The Photographer and licensees or assignees may have unrestricted use of these photographs for whatever purpose, including advertising, with any retouching or alteration without restriction.

I agree that the above-mentioned photographs and any reproductions shall be deemed to represent an imaginary person, and further agree that the Photographer or any person authorized by or acting on his or her behalf may use the above-mentioned photographs or any reproductions of them for any advertising purposes or for the purpose of illustrating any wording, and agree that no such wording shall be considered to be attributed to me personally unless my name is used.

Provided my name or the Minor Model is not mentioned in connection with any other statement or wording which may be attributed to me personally, I undertake not to prosecute or to institute proceedings, claims or demands against either the Photographer or his or her agents in respect of any usage of the above-mentioned photographs. I hereby release the photographer named above from all claims and liability relating to images, video or photographs taken of the Minor Model.

\_\_\_\_\_ I agree not to print, copy, edit, modify, and/or otherwise distribute in hardcopy and/or digital format, unless otherwise described herein, any of the photographs supplied to me for viewing, proofing, and or any other reason provided The Focused Lens, L.L.C. logo is included as a watermark on the photographs.

\_\_\_\_\_ Not For Resale: I agree that I will not print, reprint, edit, modify and/or otherwise use the photographs and any reproductions of the photographs on any internet site, either public or private, in which a fee is charged to access the photographs taken by Photographer. This Not For Resale clause agreement is perpetual for any photographs taken by Photographer during the terms of this agreement.

In exchange for the Minor Model services, The Focused Lens, L.L.C. will provide: 1) a maximum of three watermarked, digital photos for the Minor Model to share on social media provided they are not modified or otherwise edited, 2) quantity of six, color photographs, size 4X6 and 3) one, 8X8 photograph collage of pictures chosen by The Focused Lens, L.L.C.
