

OLD WESLEY R.F.C. – PLAYER MEMBERSHIP RENEWAL 2016/2017

DIRECT DEBIT FACILITY

Dear Playing Member,

As you may be aware the club introduced during the 2015/2016 season a new electronic membership system to allow our club to become more efficient and effective in how we manage our membership moving forward.

All annual membership subscriptions last season were only payable electronically by logging onto the new system and paying the membership subscription invoice online via debit card or credit card in full. This facility is still in place, however for the 2016/2017 season we have decided to introduce an alternative direct debit 'DD' payment option to allow players to spread the cost of their membership over a <u>period of 5 months</u>. Should you wish to avail of this option the first direct debit would debit your designated bank account on 30th September with the last payment being collected on 31st January each season.

The membership subscription rates for the current season are as outlined below.

Please note that all membership subscriptions are payable <u>no later</u> than 30 September each year. In the event that your subscription is not paid in full or you have not signed up to the direct debit scheme by this date your membership subscription will be considered <u>overdue</u>.
