

Membership Meeting Minutes of August 2, 2006 Schultz Center

Pete Weaver, President called the meeting to order at 6:30pm. There were 61 persons in attendance.

The Deadline for FHSAA registration is September 1, 2006. Late registrations shall incur a \$10 late fee from the FHSAA.

The FHSAA Rules Clinic will be presented at a future date to be determined date by SABO. The FHSAA rules exam is scheduled for Monday November 6, 2006 at 6:30 pm at Sandalwood and Ed White High Schools. Failure to attend a FHSAA Rules Clinic or take the Rules Exam shall incur a \$50 fine from the FHSAA for each occurrence.

All members must comply with the Provisions of the Florida Jessica Lunsford Act which provides for the completion of a Level 2 Background screening for all Sports officials. Dues for the 2006/07 season are \$30 for returning members and \$35 for new members. The deadline for Dues for returning members was the Organizational Meeting (July 26<sup>th</sup>) Dues paid after this date incur a \$10 late fee.

<u>Commissioners Report</u>: Nile Dixon asked the members for their help in keeping assignments, and working the Duval County Middle School Girls Season which runs from September 5<sup>th</sup> to October 19, 2006. Most games will be played on Tuesdays and Thursdays with a 5:00 p.m. start. Pay per official shall be \$35 per six minute quarter game plus eight dollars travel per official.

To help in scheduling, the Commissioner divided Duval County into six (6) zones. The Zone List will be posted on the Commissioners page on the website <a href="www.sabo.cc">www.sabo.cc</a> those interested in working the Girls Middle School season were asked to contact the Commissioner and indicate which zones they preferred to work.

The Duval County Public School schedule should be received by August 27<sup>th</sup> Schedule changes after this date shall incur a \$25 fine to the school.

Members shall be responsible for preparing and printing their mailing labels (Avery 5160) and w-9's necessary for completing pay vouchers at each school site. The Schools shall have a pay voucher form at the game site. Decorative mailing labels will not be accepted by the schools. The officials Name, Address and Zip Code are the only information to place on the label.

The Commissioner said that the Referee for each game shall file a game report on the Arbiter for each game worked.

Good sportsmanship at a school should also be reported in the game reports, as we would like to nominate schools for the FHSAA end of season Sportsmanship award program
