Date and Time (*This date is mandatory*):

• May 2, 2014 - 8:30 - 9:30 p.m. - Mascot skits and cheers

Location:

All aspects of SFA tryouts will be held on the SFA Campus in the HPE Complex.

Attire:

• All candidates must provide mascot outfit they feel represents the traditional Lumberjack or Ladyjack, while also displaying personal ideas and character.

General Requirements for Tryouts:

- Mascots will be assigned a cheer and will perform with the cheerleaders during tryouts. Candidates do not need to learn the motions, but they do need to be able to show how they would participate with cheerleaders in a game day / time out situation.
- Each mascot candidate will need to choreograph and perform a skit, no more than two minutes in length. This skit should incorporate crowd involvement and candidate personality.
- Candidates will also go through an interview process. Interviewers will include Spirit Coordinator, spirit team coaches, spirit team members, Traditions Council members, and Student Government officers.
- During tryout weekend, mascots will be expected to show their abilities to interact with current and potential cheer team members, as well as crowd members at this event.

Eligibility to Tryout:

- Mascot Application & Application Agreement
- \$25 Mascot Application Fee (non-refundable)
- Close-up Photograph
- 3 Letters of Recommendation
- High School or Transfer School Transcripts
- Waiver of Liability, signed by a parent if you are less than 18.

- SFA Letter of Acceptance
 - Must be accepted to SFA as a full time student or must have applied and submitted your transcripts and test scores for admissions.

If you do not have ALL of this information, you will NOT be allowed to participate in the tryout.
