<p>Apply in person for a U.S. Passport at the Orange Post Office or another location that will accept passport applications as soon as possible.</p> <p>Bring completed forms, parent(s) and passport photos. Do not sign forms until asked to do so.</p> <p>One parent must attend for youth age 16 & 17. Both parents must attend for youth younger than 16, or provide notarized consent form from the non-attending parent.</p> <p><i>** Youth who are not citizens of the United States should contact the Consulate of their country of citizenship for questions about obtaining a passport and international travel.</i></p>	<p>Passport Application Location & Hours: Orange Post Office 1075 North Tustin Street, Orange CA 92863 Phone: 714-843-4200 Hours: Mon-Fri_9am-2pm. Call (714) 639-7699 for an appointment.</p> <p>To find a complete list of locations near Orange High School, Click here.</p> <p>Passport Timing: Apply as soon as possible. <u>Passports must be received on Friday, April 24, 2015.</u> It takes four to six weeks to process a passport. Fill Out Application – Form DS-11: Application For A U.S. Passport 2. Submit Application In Person – Form DS-11: Application For A U.S. Passport with one parent if youth is 16 or 17, or both parents when youth is 15 or younger. 3. Submit Evidence of U.S. Citizenship – Birth certificate needs to be a certified full-length certificate. It can take three weeks to obtain birth certificates from the State of California. See links on the bottom middle. 4. Submit Evidence of Relationship Between Child and Parent(s) / Guardian(s) Minor's certified U.S. birth certificate with both parents' names. 5. Present Identification of Child Parent(s)/Guardian(s) 6. Submit a Photocopy of Child and Each Parent/Guardian ID Document To Be Presented (copy front and back on 8 ½ by 11 paper) 7. Provide Parental Consent – for minors under 16 only – both parents must attend or provide written and notarized parental consent for non-attending parent. 8. Pay the Applicable Fee for passport, execution fee, post office fee & delivery fee. 9. Submit One Passport Photo – On photo quality paper, 2 x 2 inches (51 x 51 mm) in size. The Post Office will take a passport photo for \$15.
