## 2014 Arkansas Amend Instructions for TurboTax CD/Download:

- 1) Select and open the federal return that you and your partner filed together with the IRS.
- 2) Select **File** and **Save As** "Amended 2014 return" before you update TurboTax to preserve your original return.



- 3) Go to the Personal Info tab.
- 4) On **the Your Personal Info Summary** screen, click the edit button next to the first partner's name.
- 5) Continue through screens until you see the **Were You Married?** screen.
- 6) On the Were You Married? screen, indicate Married instead of In a same-sex marriage
- 7) Indicate **"yes"** to the question on filing together and click **Continue.** This change to your filing status allows you to enter information for your state return.

## Now we'll work on your Arkansas return. We'll create an original filing jointly Arkansas return and then amend it.

- 1) Go to the **State Taxes** tab and then click **Continue.**
- 2) Click edit button for Arkansas.
- 3) Go through all of the Arkansas interview, answering questions for both you and your spouse.
- 4) When you see "Amend a Previous Arkansas Return" screen, indicate No. We will amend later.
- 5) Continue through screens until you see the **Smart Check Complete** screen.

## Let's amend that Arkansas return now.

1) Go to **Federal Taxes** tab (if using the Home and Business Product, go to the **Personal** tab) and then select the **Other Tax Situations** tab



2) On the Other Tax Situations screen, scroll down to Other Tax Forms and next to Amend a Return, select the Start button.

- 8) On the second screen, you'll see Let's Amend Your Arkansas Return screen. Indicate Yes, let amend and get it done. Click Continue.
- 9) On the Amount Paid or Refunded on Your Original Return screen, remove any amounts showing and enter any refund and/or tax paid from the original Arkansas returns for you and your spouse. Click Continue.

- 12) On the **Tell Us Why You're Amending Your Arkansas Return** screen, enter the following and the click **Done.**

With the 2015 U.S. Supreme Court Ruling (Obergefell v. Hodges), this Arkansas return is being filed as married filing joint for two prior Arkansas returns that were filed as single. Attached are copies of the original married filing joint federal return and both originally filed Arkansas returns.

- 13) On the Let's Make Sure You're Ready to Review screen, click Continue.
- 14) When you see the **Smart Check Complete**, go back to the **Federal** tab (for Home & Business product, the Personal tab) and **Other Tax Situations** tab.
- 15) Scroll down to Other Tax Forms, and click Update for Amend a Return.
- 16) On the Do you need to change anything else? screen, click Done.
- 17) On the Do you still receive your mail at this address, review the info and select Continue.

- 19) On the **Let's make sure your taxes are correct** screen, select **Continue** and complete all final review questions, if any. If a screen asks for the explanation of changes for a Form 1040X, ignore that screen.



- 20) After you have completed your final review, select Continue.
- 21) On the **Your Amended Return Summary** screen, click **Continue.** (This summary is for a federal amended return.)
- 22) You are now ready to print your return to file. On the You're Done! Print and Mail Your Returns, select Print Return.

## 25) After printing your return,

- The instruction letter will indicate any balance due that you need to pay or refund that you will receive with this Arkansas amended return.
- The instructions will also tell you the address to mail your return.
- Be sure to print out an extra copy to keep for your files.
- 26) Save and close this tax return.
- 27) Open previous data files and print copies and attach to the amended Arkansas return, the following:
  - a. A copy of the original federal return filed.
  - b. A copy of each of the 2014 Arkansas returns originally filed as single.
