

# CDS Sale Horse Presentation

Saturday and Sunday

Sept. 21 – 22, 2013 at MEC

A Sport Horse Sale Presentation has long been a popular marketing tool in Europe. In an effort to expose our California sale horses to different opportunities, the CDS Board has approved the idea of a Sale Horse Presentation at the **CDS/USDF Region 7 Championships**. A range of horses will be presented, from Young horses, FEI horses and horses suitable for amateurs and juniors.

As spectators, there are several advantages to having a number of sale horses together in one place. They will be able to study their conformation and disposition, and see the horses ridden over several days. **Tentative Presentation Schedule for Saturday is for 12:30 in the main ring and Sunday at 12:30 in Ring 4 next to the main ring.**

The horse may NOT be ridden by anyone other than the authorized riders on horse show grounds. A separate appointment must be set up to have a prospective rider try your horse **off the show grounds**. CDS takes no responsibility of the condition any sale horse or factual account of the bio.

## General Rules:

1. All sale horses must have a signed sale horse entry form. Each horse will be assigned a number. All horses must wear a number when out of the stall.
2. Sale horses may only be ridden by authorized riders, whose name appears on the official entry form.
3. Closing date for the sale horses Monday Sept. 9.
4. A schedule of schooling and presentation times will be posted at show office.
5. All sale horses must have a stall. Stalls for Saturday only are \$50.00  
A short bio of the horses' training history and/or show record for the announcer must be provided with your entry. CDS take no responsibility of the condition of any sale horse or factual account of the bio.
6. A "special" sale horse section will be included in the official show program listing all the sale horses with their basic information.
7. Any disputes will be resolved at the discretion of the CDS Sale Committee.
