Parking Ordinance/ **Restrictions Coming to** Santa Venetia

For the past few years, the SVNA has been addressing issues and complaints regarding the south shoulder of North San Pedro Road between La Pasada and (east) Vendola Drive. The number of vehicles and commercial trucks has increased immensely. It only worsened when the City of San Rafael enacted their own Parking Ordinance restricting oversized vehicles within the city limits (July 2016). We saw those trucks move to a new location - on North San Pedro Road. This situation has now become a safety hazard.

Last August, the shoulder was closed for clean-up, repair, and mowing for the month. The majority of trucks left the neighborhood while the work was ongoing. We know the majority of these trucks are from outside the neighborhood, simply using our streets as storage.

There has been a lot of outreach on this subject: The SVNA Board has discussed this issue frequently with Supervisor Damon Connolly. The Santa Venetia Parking Committee met on several occasions to problem-solve. The SVNA, with our Supervisor and County Staff, has held two public meetings on this issue. The SVNA Communicator has had several articles on this subject. And as well, DPW just recently flyered vehicles parked along





Supervisor's Corner -Parking, Traffic & Safety

Santa Venetia has a Community Plan! First I'd like to thank Christine Gimmler for her excellent work with

the community representatives in creating a great product – the Plan is very readable, interesting and substantive. The committee put in many hours of time in meetings, but really they lived this project over the last several years. People who step up to this kind of commitment on behalf of their community take on a great responsibility, and these volunteers took that responsibility very seriously.

Santa Venetia is unique, which is one of the reasons a community plan is important here. We are surrounded by beauty, from the San Pedro Ridge to the historic baylands and tidal marshlands of San Pablo Bay, with a significant creek running through it. There are a few sites in the community that remain of particular interest due to being subject to some level of possible development, and this plan provides helpful policy guidance.

The Community Plan fully embraces the watershed approach to planning, recognizing that some parts of the community are more vulnerable to tidal water but all parts of the community are part of a watershed system. And the plan recognizes the importance and opportunities inherent in many of the initiatives we have underway to further enhance this region, such as the County's purchase of **Buck's Landing** and efforts to restore McInnis Marsh.

Approved by the Board of Supervisors, the Santa Venetia Community Plan is now a blueprint that we and the community can utilize and be proud of for many years to come.

I also want to thank everyone who participated in the two community meetings to discuss parking issues, one in September, 2016, and the other in January of this year. Our office has fielded calls for years complaining of parked cars, trucks and other commercial vehicles along N. San Pedro Road, contributing to the degradation of the roadway, safety issues and blight.

The City of San Rafael was the last city in the county to ban parking of oversized vehicles and RVs and the fall-out is that many of those oversized vehicles have found their way to unincorporated roads and streets, which are in effect being used for long-term storage for commercial vehicles not in daily service.

This problem is not confined to Santa Venetia, but has affected some particular areas of the unincorporated parts of the county, and has negatively impacted the very character of the communities. Our Board approved an "umbrella" ordinance, creating a menu of options to restrict parking ranging from "no parking zones," to "no overnight parking" of certain kinds of vehicles. We now have the ability to create parking restrictions by street or by neighborhood, responding to the specific problems that exist and at the same time, keeping to a minimum, any unintended consequences.

We had a good turn-out at these community meetings and the consensus was to 1) establish a "no parking" zone along N. San Pedro Road between La Pasada and Vendola, and to 2) ban overnight parking of oversized commercial vehicles throughout the Santa Venetia neighborhood (vehicles that fall under this category are a combination of vehicles, trailer and/or auxiliary equipment with a commercial license plate and overall length from bumper to bumper of more than 22 feet between the hours of 11pm and 5am). This request should be coming to the Board at its April 25 meeting and if approved, will go into effect once the signs are erected throughout the community.

A Frank Lloyd Wright Doghouse: **Coming to the Civic Center Library**

On June 8, in honor of the 150th anniversary of Frank Lloyd Wright's birth, the Civic Center Library, in partnership with the Frank Lloyd Wright Civic Center Conservancy, will be displaying the only doghouse ever designed by Frank Lloyd Wright.

The doghouse – known as Eddie's House – after the Berger family's Labrador retriever, was donated to the County of Marin by Jim Berger

Berger grew up in San Anselmo in a Wright-designed home that today is widely known as the Berger House. His parents, Robert and Gloria Berger, commissioned Wright to design the house in the early 1950s, and it was built to specifications by **Bob Berger** over the course of 20 years. Wright also designed a triangular doghouse on the back of an envelope - at no charge - when Jim Berger, then 12 years old, wrote to Wright and requested plans.

Bob Berger built the first doghouse in the late 1950s, but it was disposed of by the family a few decades later. In 2011, Jim Berger, by then a retired cabinet maker living outside of Sacramento, received permission to build an exact replica of the doghouse, per the original plans, for a documentary about Wright and his legacy.

January Community Meeting –

Supervisor Connolly Delivers Annual "State of the County" Address and Moderates the Parking Discussion

On January 31, **Supervisor Damon Connolly** spoke to the SVNA in what is always the best-attended meeting of the year - in this case, a double-

The first meeting was called to order by Vice President Gina Hagen, who welcomed attendees and invited all to join the SVNA (by paying their 2017 dues) and volunteer for various committees or the board. She introduced our speaker, formerly a member of the San Rafael City Council, and now our County Supervisor appearing for the third time at the SVNA general meeting, who in turn introduced his aide, Susannah Clark.

Supervisor Connolly stated that the county is the level of government where it is possible to get things done, for example, the County's recent purchase of Buck's Landing, long desired by the community as access to the Bay. He also referred to Gallinas Watershed as a "jewel" that needed to be managed on a watershed-wide basis, an approach also being followed by state and federal agencies. Related issues are flood control (including who owns Gallinas Creek?) and dredging: CSA #6 is considering a "geomorphic" dredge. Spoils may go to the McInnis Marsh project, in which case we may get full funding. He thanked the new and retiring members of FCZ #7, our Flood Control Advisory Board. The Soccer Complex development at the San Rafael Airport has a permit for a new bridge and a building to be completed in 2018. The Santa Venetia Community Plan was due to go to the Marin County Board of Supervisors on February 14 (and has now passed).

Other County Issues:

Medical Marijuana: Outlets to be adopted include two in the 101 corridor and two in West Marin. Recreational marijuana is banned for the time being. Residents may legally cultivate six plants for personal use.

Housing: Marin residents do not want high density as a solution. County is working with landlords to curb rents and accept vouchers.

Traffic: Connolly represents Marin on the Bay Area Transportation Commission. He will keep us posted on proposals.

Another topic is the Transit Center in San Rafael vis a vis SMART plus other congestion issues.

Gina suggested people go to the County website to sign up for updates on the issues of their interest.

Parking Issues: At 8pm the Supervisor's Annual Report meeting adjourned to reconvene as a special meeting on parking issues in Santa Venetia, specifically on N. San Pedro Road opposite the two apartment buildings. The issue concerns the wide shoulder having been turned into a long-term parking lot often by large trucks and by people living/ sleeping in their vehicles. Supervisor Connolly introduced Bob Goralka, County Traffic Engineer, and Lieutenant Jeff Edwards of the Sheriff's Department. Neighbor (and Rocky's Meats employee) Christina Williams served as our translator.

Lt. Edwards said that parking was banned at that place during road work for a month and the usual trucks did not show up on nearby residential streets as had been feared. Connolly reported that the BOS had adopted an ordinance allowing for neighborhood options as to parking rules - e.g. ban vehicles over 22 feet in length, or overnight parking, etc.

Supervisor Connolly said it would be up to the community to decide what kind of ordinance we should adopt. Some residents of the apartments objected to an overnight ban because they need to park there. Some in the community would like to have a bike lane where trucks now park. Someone suggested people send Damon info on safe places to park. The conversation was long and everyone had their say and as you can imagine, this included many different suggestions and opinions. The final decision, made after a straw vote, was to move forward with closing North San Pedro Road to parking between La Pasada and Vendola and banning overnight parking of large commercial vehicles throughout a portion of Santa Venetia. This motion will go before the Board of Supervisors in the coming months.

There will be up to two dispensaries along the 101 Corridor, possibly one in Santa Venetia. Public Meetings have been held and it is in the hands of the County Advisory Committee to make a decision as to the acceptable applicants and sites. Getting to Know Levee Inspector Bene da Silva

Bene da Silva has been managing Flood Zone #7's work to inspect and improve the levees in Santa Venetia since 2005. High tides and creek levels have lapped at the timber floodwalls several times since then, and without Bene's hard work to repair timber floodwalls, implement gopher control, and maintain vegetation, Santa Venetians may have had wet feet, or worse.

Bene values the relationships he's built with property owners in Santa Venetia to obtain Rights-To-Enter to inspect and repair the levees. The levees are the first line of defense against flooding, and with most of them on private property, these permissions are crucial. He gives a

shout out to SVNA and long-time Santa Venetians for assisting in reaching out to residents.

Aside from flood control duties, Bene serves on the County's Urban Search and Rescue Team and is ready to deploy within 45 minutes. He would jump at the chance to employ his climbing and technical rope skills in a "high-angle" rescue.

Bene loves music and plays guitar, mandolin, and banjo. He jams with the County's house band every Friday, playing songs from the Grateful Dead, Bob Dylan, and other American classics. In fact, Bene came up with band's name: the **County Crows**. Bene would be thrilled if you came to hear the Crows play this summer at the County Fair.





Adams, we again started discussing this possibility. In 2009 a Committee was set up and the call went out for members of our neighborhood to serve. Members of this Committee held ongoing meetings (including our Supervisor and County Staff) and got to work reviewing the needs for our community, with hopes of creating a viable first draft for our Community Plan.

With then-**Supervisor Susan Adams** contributing a large amount from her Discretionary Fund, the neighborhood pitched in with a raffle, spearheaded by **Bonnie Monte**, to raise the remaining amount needed to hire **Godbe** to put together a survey for our residents. The survey was done in 2011 and we were told the interest and rate of return was incredibly high – a point of pride.

In early 2013, the County made their decision and announced that Santa Venetia would be one of the two communities in Marin to get a Community Plan and our Committee started working with County Staff.

This long-overdue document will establish what we value about our neighborhood and provides direction on what we want to preserve or improve, and what we would like to change. These guidelines will be invaluable when future issues arise affecting traffic, development, transportation, flooding, and more

Our hard-working Committee has changed a few members throughout this time but the early group and the later group, and some that stayed the whole time, put in many hours of work to get this project done for the community, meeting monthly from the beginning through completion. Thank you to the hard-working Santa Venetians who served on the Community Plan Committee at one time or another: Giselle Block, Jane Brand, Jackie Garcia, Russ Greenfield, Mary Hanley, Tamara Hull, Jonathan Metcalf, Roger Heller, Bonnie Monte, Gary Robards, Oscar Segura, Shelley Sweet, and Mark Wallace.

Thank you to County Staff Christine Gimmler, Jack Liebster, and Lauren Armstrong; to the Planning Commission; and to Supervisor Damon Connolly and Past-Supervisor Susan Adams for their assistance, direction, and guidance.

And thank you to all the Santa Venetians who completed the survey, attended the public meetings, and commented throughout the process – as usual, we showed the County that we are interested and engaged when it comes to our Community.
