TO RESERVE YOUR PARTY DATE, A 50% DEPOSIT IS REQUIRED UPON THIS AGREEMENT. THIS DEPOSIT WILL APPLY TO THE BALANCE OF YOUR PACKAGE PRICE.

FINAL PAYMENT IS DUE DATE OF THE PARTY: 50% + \$15 per additional guest attending. A guest headcount will be taken at beginning and end of party by the party planner.

Example:

Basic Package: \$150 deposit + \$150 due on day of party= \$300 package price Theme Package: \$175 deposit + \$175 due on day of party= \$350 package price

Maximum time allowed for parties is two (2) hours unless otherwise noted. Any items left in the room after renter leaves will be discarded. Please be sure you have all belongings before departure. Set up specifications and times should be discussed with DanceVersE party planner at least 2 weeks before rental date. Any special party arrangements must be approved by



DanceVersE staff before rental. Parties of more than 40 people must first be approved by DanceVersE staff and additional charges may apply.

Two week advance notice is required for all rentals, and $\frac{1}{2}$ payment is required to hold the reservation. **RENTAL FEES ARE NON-REFUNDABLE**.

Rental Dates and Times are subject to availability.

RESPONSIBILITY AND SAFETY ISSUES:

Renter is responsible for the behavior of party guests—including any damages incurred during their stay at DanceVersE. Renter and guests are expected to respect the property—excessive noise, running, vandalism, alcohol, smoking, open flames, and any type of unsafe behavior is not permitted. Anyone found disobeying these rules will be asked to leave the property, rendering payment. DanceVersE is not held liable for any injuries or allergies that may occur to guests or renters.

Event Planners will help clean up once the party is finished. However, the renter is expected to leave the room in the same general condition they found upon arrival. There will be a \$40 fee for rooms left untidy.
