2014–2015 Dependent Verification Form

Your 2014–2015 Free Application for Federal Student Aid (FAFSA) was selected for review in a process called verification. Under federal regulations, some students are asked to validate the information provided on the FAFSA to assure that the information provided is accurate. We will compare your FAFSA with the information on this form and with any other required documents. If there are differences, your FAFSA information may need to be corrected. You and at least one parent must complete and sign this form, attach any required documents, and submit the form and other required documents to the Financial Aid Office.
