The existing beneficiaries who are getting Financial Assistance from the Trust till October 2014 may also submit fresh application as per eligibility criteria.

### Eligibility Criteria

- (a) Age 50 years and above (Age Proof-Certified True copy of PAN Card or Voter Identity Card)
- (b) Annual Income from all sources should be below Rs.24,000/- per annum. (Income Proof Certified True Copy of Income Tax Return Filed, if any, or the copy of Bank passbook of last three years of self and other earning family members to ascertain the financial status)
- (c) Must have performed in at least five films. (Performance proof: Certified True Copies of list of films performed, Photographs of Films, Certificate from Producers & newspaper / magazine cuttings).
- (d) Must not be performing currently in any type of film media (TV Films, Short Films, Documentary and Advertisement etc.
- (e) Only Cine Artistes are eligible, junior Artistes, Technician, Musician etc. are not eligible to apply.

- [d] Must not be performing currently in any type of film media [TV, Films, Short Film, Documentary and Advertisement etc].
- [e] Only Cine Artistes are eligible, Junior Artiste, Technician, Musician etc. are not eligible to apply.

#### General

1. Grant of Financial Assistance from the Trust Fund to any Cine Artiste is not as a matter of right. Assistance would be extended depending on the applicant satisfying the eligibility and also keeping in view the financial allocation available for the purpose. The Trust reserves the right to reject or accept any application without assigning any reason thereof.

2. Applications in the prescribed format must be filled up and must be duly recommended by the Union / Association to which the Cine artiste is / has been affiliated and to be forwarded to respective Secretary / Regional Secretary [mentioned at sr.no. 3] alongwith latest two color photographs.

4. For the purpose of these rules, the term 'Dependent' means and includes Spouse of a deceased Cine Artiste who has registered with this Trust and will have to apply along with death certificate of the Registered cine Artiste on whom he / she was dependent to become eligible to receive on time help of Rs. 9,000/- from the Trust.

5. The Trust will allot Registration Number to those Cine Artiste who they find eligible for claiming financial assistance, presently Rs. 750/- p.m., under the rules of the Trust. Quoting of the registration number on all the correspondence with the Trust is mandatory.

#### PROCEDURE

Application made for any assistance should be addressed to the Secretary / Regional Secretary of the Trust. Normally all cases for financial assistance would be discussed and decided by the Regional Sub-committee of the Trust at Mumbai, Chennai and Kolkata. The General Body of the Trustees would only decide on policy issues or on such matters that fall outside the prescribed guidelines. The Regional Sub-committee would consist of the Chairman of the Trust, the Managing Trustee, Financial Advisor, Local Trustees and Secretary / Regional Secretary of the respective regions.

In cases of emergency pertaining to compensation in case of death or other similar emergencies, which warrant immediate financial assistance, the Chairman or the Managing Trustee is competent individually to grant the financial assistance upto limit as the Trustees may decide. The Secretary would put up such cases for ratification in the next meeting of the Trustee.
