- The employees attended a two-day workshop on water valves and hydrants.
- Regular flushing has been completed on problem areas: Thomson Meats, Dairy Queen, Crawford West and KFC.
- The tender is being drafted for the BCF waterline replacement program, as well as a tender for 360 metres of pavement on Shadd Street & Burrows East.
- The curb and gutter installation on Regent will not be proceeding as the City could not obtain unanimous consent of the property owners.
- A number of trip hazards have been identified in the downtown core.
