The undersigned hereby authorize(s) and consent(s) to the MINOR sailing on board an NCL ship and further hereby authorize(s) and consent(s) to the examination, diagnosis, treatment and care rendered to the MINOR which, in the sole opinion of the ship's physician or any other medical personnel acting under his or her supervision, may be necessary or appropriate under the circumstances.

The undersigned further agree(s) to be fully responsible for any and all medical expenses associated with the diagnosis, care and treatment of the MINOR, including emergency air ambulance evacuation, if necessary, and to indemnify and hold NCL and its vessels harmless from any liability for any and all costs or expenses incurred as a result of the medical treatment of the MINOR.

The undersigned shall indemnify and hold NCL and its vessels harmless from any and all bodily injury, death, property damage, cost and expenses (including reasonable attorney's fees) suffered by any person or entity, including, but not limited to, other guests, NCL and its employees and vessels due to any act or omission of the MINOR while on board an NCL ship, whether intentional or not. The undersigned affirm(s) that the undersigned has/have read the terms and conditions stated in the guest ticket contract accepted on behalf and given to the MINOR and hereby acknowledge(s) and agree(s) for the undersigned and the MINOR to be fully bound thereby.
