- 1.2 Epcm noted that all questions concerning the bid are to be in writing and faxed or emailed to Epcm.
- 1.3 Epcm stated that the project is subject to prevailing wage rates and the project would be registered with PA Department of Labor & Industry by Epcm.
- 1.4 Epcm reviewed the project scope with Gig Settle of Gannett Fleming. The basis of design is Fanwall Technology and an Addendum is being prepared to include modifications to the Specifications.
- 1.5 Epcm explained that the intent is to begin the project on a Friday evening and complete the following week. This will allow the project to be completed over the Spring Break from March 9, 2009 March 15, 2009.
- 1.6 Bidders were instructed that all controls must be compatible with Johnson Controls (JCI) Metasys Technology. HACC will complete final programming of the Johnson Controls under the HACC Master Contract but the Contractor is responsible for coordination with JCI and for proper operation of the equipment.

- 1.7 Epcm noted that consideration was given to equipment access through existing openings. The contractor is responsible to modify new equipment as necessary to get the material into the work areas.
- 1.8 Contractors were advised that they may use the building restrooms during construction.
- 1.9 HACC will work with the Contractor to provide staging areas to hoist material to the penthouse.
- 1.10 Contractors are responsible for protection of the roof during hoist operations and during the duration of the project.
