



2014 CLUB BALE DECORATING CONTEST

WASECA COUNTY 4-H

CONTEST RULES

1. Each club who returns the registration form below will be given one (1) large round bale to decorate that will be donated. If you would like to use extra square bales you must supply your own.
2. The club must decorate the bales (*not around the bales, do not cover the bales with sheets, tarps, etc.*).
3. The dimensions for the exhibit to sit in are: 8 X 8 ft (*approx.*).
4. **Bale locations will be assigned based on the order the forms are received in to the Extension Office.**
5. Clubs who spray paint their bale near a building must take measures to keep the paint OFF the building. If evidence of paint from the club's bale is found, the club will be assessed a \$50 damage fee.
6. The bales can be decorated anytime between Monday morning (*July 14th*) and Wednesday morning at 12 noon (*July 16th*). **Your bale must be completed and in your designated area by 12:00 NOON on Wednesday, July 16th.**
7. Blue, red, and white ribbons and premiums will be awarded, along with a Grand Champion and Reserve Champion. The Waseca County Fair Board pays premiums for the contest as well as a \$50 bonus for the Grand Champion and a \$30 bonus for the Reserve Champion.
8. **FORMS ARE DUE TO THE EXTENSION OFFICE BY MAY 15. If a club does not turn a registration form in by May 15th, they will either need to provide their own bale OR they must enter and bring a different "club exhibit" to the 2014 County Fair (Banner, Community Pride, Scrapbook, or Promotion/Display).**
