

Perimeter School Reenrollment 2012-2013 Paper Form

SELECT REENROLLMENT FEE PAYMENT OPTION

Re-enrollment fees will be posted to your FACTS account within 5 days of the completion of your FACTS tuition payment agreement. The rates are as follows:

- \$500 per student (first and second student in family)
 - \$400 per student (for third student and beyond in family)
- add \$35 fee for *each* middle school child

Reenrollment fees will be the first transaction billed through our new FACTS system. You may elect to have re-enrollment fees drafted in either **one** payment on February 24th or in **two** equal installments on February 24th and March 16th by selecting the desired option below.

PARENT CONTRACT (Includes legal guardians)

By checking the box at the bottom of the page, I indicate that we (all covenant parents) have read, do understand, and do agree with the *Parent Contract*. In making application to attend Perimeter School,

1. We do affirm our commitment to a biblical view of parenting which includes:
 - Our ultimate responsibility to educate our children according to Deut. 6: 6,7.
 - Our submission to the authority of Jesus Christ, the leadership of our church, and civil authorities.
 - Our regular practices of spiritual growth that include personal, family, and corporate devotion and worship.

2. We do affirm our commitment to the educational philosophy of Perimeter School which includes:
 - Allowing the school to assist us in the individual education of our child.
 - Submitting to the school-wide policies governing all students.
 - Praying regularly for all the school staff, the faculty, and other school families.

3. We do affirm our commitment to teaching and chaperoning enrichment days and field trips as is required and stated in the Student Handbook for our child's grade level and class.

4. We do affirm our commitment to parent and student punctual attendance requirements at school functions which include: school-wide campus meetings, teacher conferences, class parent meetings, regular school days, and enrichment days (including field trips and service projects). Non-compliance may jeopardize re-enrollment.

5. We do affirm our commitment to a biblical model of communication which includes:
 - Following requested channels of concerns or criticisms by going first to the appropriate party (teacher, principal, etc.).
 - Refraining from giving bad reports or gossiping about issues with others.
 - Bringing constructive suggestions to the administration or School Ministry Team in writing.
 - Letting the administration know if the school's commitment to competent teaching, solid curriculum, regular feedback, proper supervision, cooperation with the home, and love and respect for your child is not being met.

6. We do affirm our commitment to giving the teachers and principals full discretion in disciplining our children which includes:

- Praise as well as rebuke.
- Spanking for serious offenses under careful, appropriate guidelines.
- Expulsion from school if behavior warrants such.

7. We do affirm our commitment to being responsible for assuring our child's compliance with school rules or withdrawing him, which includes the recognition that the school retains the final word on a student's discipline, suspension, probation, or expulsion.

8. We do affirm our commitment to accepting the breadth and scope of Perimeter School's program, realizing that the school cannot meet the educational needs of all covenant children. The school retains the right, after careful testing and examination, to deny admission or re-enrollment to any student whose needs are not best met by its program. This may include required outside tutoring or therapy in order for a student to be enrolled.

9. We do affirm our commitment to the school as a non-profit ministry of Perimeter Church which includes:

- Recognizing that members of Perimeter Church are given enrollment priority if other admissions standards are met.
- Recognizing the school's need for faith giving beyond the required tuition to help fund teacher emergency needs, scholarships for students, and special capital expenditures.
- Recognizing the school's submission overall to the authority of the Session of Perimeter Church.

10. We affirm our commitment that once new language: re-enrollment has been completed (both a FACTS tuition agreement and the Parent Contract have been signed, we are responsible for paying the full tuition and fees for the academic year. Because the school's expenses are incurred on an annual basis, the school cannot release the parents from their financial obligation. Extenuating circumstances may be appealed in writing to the School Ministry Team. Should the vacancy created by a family's withdrawal be filled during the school year, the family may be released from their remaining financial obligation, subject to a review by the School Ministry Team. Records will not be forwarded to another school until all financial obligations have been satisfied.

11. We affirm our understanding that delinquent accounts will result in:

- Late fees on tuition and fee payments.
- Transcripts of student records withheld until payment is made.
- Eighth graders not participating in graduation until account is paid in full.
- Loss of enrollment priority for the following year.
- Removal from school if the account falls two or more months in arrears.

If legal action is required to collect tuition, the undersigned will be responsible to pay reasonable attorney fees.
