## ADDENDUM TO MVC EXCHANGE COMPANY ENROLLMENT AGREEMENT Providing Access to Marriott Vacation Club Destinations<sup>TM</sup> Exchange Program

This Addendum to MVC Exchange Company Enrollment Agreement ("<u>Addendum</u>") is entered into as of the \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_, by and between \_\_\_\_\_\_ ("<u>Owner</u>") and Marriott Resorts, Travel Company, Inc., a Delaware corporation d/b/a MVC Exchange Company ("<u>MVCEC</u>").

WHEREAS, Owner and MVCEC executed that certain MVC Exchange Company Enrollment Agreement, dated \_\_\_\_\_\_, 20\_\_ (the "<u>Enrollment Agreement</u>"), pursuant to which Owner enrolled in the Program and became an Exchange Member.

This Addendum modifies the terms and conditions of the Enrollment Agreement as more particularly set forth herein. Any conflict or inconsistency between this Addendum and the Enrollment Agreement shall be governed by, and resolved in favor of, this Addendum.

The Enrollment Agreement is hereby modified to include the following:

1. Subject to the terms and conditions of this Addendum, MVCEC hereby awards to Owner \_\_\_\_\_ Vacation Club PlusPoints ("<u>PlusPoints</u>"). PlusPoints will be deposited in Owner's account within sixty (60) days after the date of Owner's enrollment in the Program.

2. Owner may use PlusPoints to reserve Accommodations and other Exchange Benefits within the Program, subject to the terms and conditions of the Exchange Company Documents.

3. In the event Owner rescinds the Enrollment Agreement within the applicable rescission period (if any), or otherwise fails to comply with the terms and conditions of the Enrollment Agreement, Owner will not receive the PlusPoints referenced in this Addendum.

4. PlusPoints issued on or prior to December 31, 2010 will expire on December 30, 2011. PlusPoints delivered on or after January 1, 2011, shall expire one year following their date of delivery to Owner.

5. Owner hereby acknowledges and agrees that PlusPoints are nontransferable, and may not be banked, borrowed or traded for Marriott Rewards<sup> $\ensuremath{\mathbb{R}}$ </sup> points.

Capitalized terms used and not otherwise defined in this Addendum have the meanings set forth in the Exchange Procedures for the Marriott Vacation Club Destinations Exchange Program. With the exception of terms and provisions specifically set forth or modified herein, all other terms and provisions of the Enrollment Agreement shall remain in full force and effect.
