## Helping Lisa and thousands more young people like her



### A lifetime worth of love

Seven year old Jack will remember making snow angels in the garden at midnight this winter.

His foster mum and dad woke him up, put a snowsuit on over his pyjamas and brought him out to play when the snow began to stick. They didn't want him to miss out if the snow had melted by morning because Jack has a life-limiting illness and is unlikely to live to adulthood.

His foster family love him as one of their own, and are helping him to pack as much as he can into his life now.

'He is a superstar' says his mum Cathy.'It is our goal in life to make every single day special for him. Jack might live only to 15 or 16, but he will have had a lifetime worth of love.'

The Barnardo's fostering assessment process was long and invasive but, Cathy believes, it was definitely worth it. 'The Barnardo's social workers who did our assessment were very sensitive and let us take our time. They were very supportive.'



Jack was 3 years old when he first came to stay. He didn't speak and Cathy and lan were told that he had severe learning difficulties. But out of hospital and in a home situation, Jack thrived, defying all expectations.

'Now he is a real little chatterbox and we all spoil him. He has gone from a vegetating boy to a blossoming 7 year old.'

And of the future – Cathy says that it is hard knowing what will happen, and at times she wants the world to stop. But Barnardo's has been, and will be there to support her:

'Every time Jack says 'I really love you', or says something that indicates he is happy, then I know that whatever happens in the future, it will all be worthwhile.'



## Answering your questions

### Why should I make a Will?

Making a Will is the only way to be sure that your wishes are followed after you are gone. If you don't make one, not only will the law decide who inherits your property but you are likely to leave your loved ones with a pile of administration at a very difficult time for them. Part or all of your estate might end up going to people who you never intended to benefit. Without a Will, your loved ones may also have to pay more inheritance tax than necessary.

You may not consider yourself to be wealthy, but when you add everything up, you may find that you have more than you realise, particularly if you own your own home. All your possessions count towards the value of your estate, including your pension, jewellery, furniture, shares, etc.

### How do I go about it?

You can leave money to family and friends alongside a gift to charity, in the same Will. We strongly recommend using a solicitor. Professional advice is less expensive than you might think and having a valid and accurate Will can give you real peace of mind. This booklet outlines the information you will need to take to your solicitor.

### How do I change my Will?

It's important to review your Will regularly – at least once every five years. If you have any major life changes, such as getting married, divorced, having children or grandchildren, it's important to update your Will to take account of your new circumstances.

If you only need to make minor changes, making an amendment (called a codicil) is easy and inexpensive to do.



### Can I save on tax by leaving a gift to charity?

Yes. Leaving a gift to Barnardo's could reduce your inheritance tax bill, because your gift is removed before the value of your estate is calculated for tax.

You could even avoid inheritance tax completely by pledging to give everything over and above the inheritance tax threshold. When you write your Will, your solicitor can advise you further on this. (For information about inheritance tax, visit www.hmrc.gov.uk/cto/iht.htm)

### How do I leave a gift to Barnardo's in my will?

There are three main ways you can leave money to charity:

- You can leave a residuary gift which is the remainder after all other gifts and debts have been paid. This ensures that your family and loved ones are catered for first and what is left over can then be donated to charity.
- You can leave a cash lump sum (a pecuniary gift). You might like to ask your solicitor to index-link any cash gift to ensure its relative value stays the same over the years.
- You can leave a specific piece of property jewellery or furniture for example.

Leaving money in your Will is a highly personal and special gift. It is entirely up to you whether or not you inform us of any gift. However, knowing about your bequest will help us to plan ahead. It will also enable us to keep you in touch with our work, which we would very much like to do.

### Is the law the same throughout the UK?

No. The law in England and Wales is the same but there are some important legal differences for Scotland and Northern Ireland. This is another reason why it is important to let a solicitor draw up your Will. All of the advice in this booklet however is relevant to you wherever you are in the UK.

## Without Barnardo's, I believe I wouldn't be here now

After a traumatic early childhood, starved of love and attention, Anna spent a lot of her youth in care. After leaving school with no qualifications, she had trouble adjusting to life in the adult world. Soon after leaving school, Anna was put in touch with Barnardo's 16+ project in Glasgow. The service provides practical and emotional support for people like Anna who have been in care. Barnardo's helped her learn to deal with her traumatic past, while offering practical support with the everyday realities of life on next to no income. In Anna's words:

'I find the ongoing support I get from the service is brilliant. If I have any problems, I know I can phone up and talk to someone. For the first time in my life, I really feel that I'm part of something.'

'Since children are our tomorrow it is vital that they get the best possible start in life. I know that Barnardo's will do their utmost to bring this about for the least fortunate youngsters in our society. So I am more than willing to leave Barnardo's a legacy.'

## Someone was looking after me for a change

By the age of eight, Amy could cook spaghetti bolognaise, chilli con carne and lasagne. This was not because she had ambitions to be the next Jamie Oliver. It was simply that unless she cooked, nobody at home would have a hot meal. For Amy had become the main carer for her mum, who was increasingly disabled, and her little brother; who had learning difficulties.

Seven years on Amy is still caring for her Mum. As well as cooking the family meal, she also shops, cleans, washes and irons, in between going to school.

'I always felt lucky to have my Mum with me,' Amy says, 'but I felt quite isolated because I was always inside the house.

I get up before seven every morning to wake my brother and get breakfast. Then I get my Mum her breakfast and her medication and get her dressed before getting out to school. Usually I have made her sandwiches before I go so that her lunch is ready for her.

I'm back home after school by about five. Sometimes I have done some shopping on the way home. Then I try to do a bit of homework before getting dinner ready, doing the housework, and helping my brother with any homework. I get Mum to bed around nine, and she watches some television before going to sleep. It's often about I I o'clock when I get to bed myself.'

About two years ago Amy joined a Barnardo's young carers' project:

'When I went along to the first meeting, everyone was really friendly and it was fun. Everyone there is doing all the things that I am doing at home; it's really good because I get to speak to the people who have the same sort of problems I do.

'Barnardo's really supported me when my Mum was in hospital as well. It felt like I was being cared for and that someone was looking after me for a change.'

### Preparing for your solicitor

Before you visit your solicitor, there are a few key points you should consider:

- It is helpful to work out how much you have to leave, taking into account any property, mortgages, savings, possessions or even money you are owed. There is a checklist overleaf that you may like to fill in and take along with you.
- Who will be your Executors (or Executors Nominate in Scotland)? An
  Executor is charged with carrying out the instructions in your Will. Ideally, you
  would appoint two. They must be people you can trust, such as family friends
  or professional advisers.
- Who do you want to leave money or gifts to? You may like to list the
  beneficiaries and gifts you have in mind on the sheet overleaf. You may wish to
  leave a gift to charities you care about, as well as to friends and family. You can
  bequeath personal items as well as money or assets.
- If you wish to leave money to charity, consider whether you would prefer to leave a residuary gift (what is left over after other gifts and debts are paid), a cash gift or a specific possession.

#### Letter of Wishes

Many of us find it difficult to think about our own funeral. It may seem morbid at first but it can enable you to have a special farewell that is personal and appropriate. It can also relieve family members of a difficult emotional burden. Most importantly, knowing your wishes and carrying them out can bring great comfort and peace of mind to family members and friends.

A Letter of Wishes is quite separate from making a Will. Barnardo's can provide a template for these letters, free of charge. You can request one using the form at the end of this booklet.

## Suggested wording for your Will

The following is suggested wording to give to your solicitor.

#### Residuary Legacy

- **I.I** I give all '(or... share)' of my estate (out of which shall be paid my funeral and testamentary expenses and my debts) [and any property over which I have power of appointment] to Barnardo's (registered charity nos 216250 and SCO37605) of Tanners Lane, Barkingside, Ilford, Essex IG6 IQG and I DECLARE that the receipt of the Treasurer or appropriate officer shall be a complete discharge to my trustees.
- **I.2** I FURTHER DECLARETHAT if before my death Barnardo's has changed its name or amalgamated with or transferred all its assets to any other body then my Trustees shall give effect to the gift as if it has been made to the body in its changed name or to the body which results from the amalgamation or to which the transfer has been made.

Pecuniary Legacy

**I.I** I give to Barnardo's (registered charity nos 216250 and SCO37605) of Tanners Lane, Barkingside, Ilford, Essex IG6 IQG, the sum of  $\pounds$ ..... to be applied for its general purposes, and I direct that the receipt of the Treasurer or other proper officer at Barnardo's shall be good and sufficient discharge.

I.2 (as above)

### Specific legacy

I.I I give to Barnardo's (registered charity nos 216250 and SCO37605) of Tanners Lane, Barkingside, Ilford, Essex IG6 IQG, [write here the items you want to give] to be applied for its general purposes, and I direct that the receipt of the Treasurer or other proper officer at Barnardo's shall be good and sufficient discharge.

#### Index-linked pecuniary

**I.I** I give free of tax to Barnardo's of Tanners Lane Barkingside Ilford Essex IG6 IQG (registered charity nos 216250 and SC037605) the sum of money produced by dividing the sum of [ ] pounds ( $\pounds$ [ ]) by the index figure in the Index of Retail Prices ('the Index') for the month in which this Will is executed

and (having made allowance for any re-basing of the Index which may have happened in the meantime) multiplying it by the index figure in the Index for the month in which my death occurs.

- **I.2** If when the time comes the second of these figures is not available (because the Index has ceased to be published or for any other reason) my Trustees (making use if they wish of any other index which may seem to them relevant and obtaining any advice which they may think desirable) shall reach a decision (which shall bind Barnardo's and everyone interested in my estate) as to what in their view the second of these figures would have been if it had been available and shall use the figure on which they decide for the purposes of the calculation.
