WALT DISNEY WORLD RESORT SWEEPSTAKES OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

1. How to Enter

- a. These rules govern the Walt Disney World Resort promotion (the "Promotion") being conducted by WJMK-FM, 104.3 K-HITS (the "Station") beginning on Monday, April 8th, 2013 at 6:00 am Central Time ("CT") and ending on Friday, April 26, 2013 at 5:00pm Central Time ("CT").
- b. - d. Due to delays in the Station's streaming broadcast, listeners to the online stream may not be able to timely participate in any Station-conducted onair contests. Listeners to the online stream are encouraged to listen to the Station live on-air.

 - b. Three (3) Grand Prizes will be awarded. Grand prize consists of is a 5-day/4-night vacation for up to four (4) people at the Walt Disney World Resort in Orlando, Florida. Winner receives round-trip coach airfare from Chicago's Midway airport to Orlando's International airport for four (4) onboard Southwest Airlines, one (1) room for a 4-night stay at their choice of Walt Disney World Resort Hotels (pending hotel availability and confirmation from Walt Disney World Resorts). Prize also includes complimentary Disney transportation between Orlando airport, Disney hotel and Disney theme parks. The Approximate Retail Value ("ARV") of the prize is \$2,750.

- b. One-Hundred-Five (105) Daily Prize Winners will be awarded. You must be the 24th caller at 312-729-1043 when you hear the "cue to call" between the Promotion Dates. Each winner will receive a Fifty-Dollar (\$50) Disney Gift Card. Each Daily Winner will qualify for that week's grand prize drawing only. The grand prize drawings will take place on Friday, April 12th, Friday, April 19th, and Friday April 26th, 2013.
- c. Three (3) grand prize winners will be awarded through a random drawing, one (1) on Friday, April 12th, 2013, one (1) on Friday, April 19th, 2013, and one (1) on Friday April 26th, 2013 at approximately 4pm CST each day.
- d. Odds of winning depend on the number of eligible entries received.
- e. The winner must listen to the Station between the Promotion Dates for a chance to win.
- f. The winner will be notified by the Station by email and/or telephone following the end of the contest and to claim prize.
