## **TERMS & CONDITIONS**

The standard terms & conditions forming part of "PUC Application cum Allotment Form" are stipulated as under.

Further in such terms & conditions:

the term "Company" denotes "Fashion Suitings Private Limited" a Company incorporated under the Companies Act, 1956 and having its registered office at "RCM WORLD", SPL-6, RIICO Growth Centre, Post- Swaroopganj, Via-Hamirgarh, Bhilwara (Raj.

PUC denotes "Pick up Center" and PUC Holder denotes successful applicant of PUC.

  - A. PUC Holder shall totally concentrate over sale and distribution of Company's products. He shall not involve in any other business/employment of similar nature either directly or indirectly.

- 18. In case of any dispute among the parties hereto touching these presents the matter shall be referred to the Sole Arbitrator appointed and nominated by the Company.
