

## TOWNSHIP OF DEPTFORD BUILDING USE AND CERTIFICATE OF INSURANCE REQUIREMENTS

Prior to the use of any Township building or premises you must provide the Township with a certificate of insurance that fulfills the five requirements set forth below.

## REQUIREMENTS

- 1. Commercial General Liability with a \$1,000,000.00 Combined Single Limit of Liability for Bodily Injury and Property Damage, including Blanket Contractual, Premises and Products Liability.
- 2. Private Coverage to be Primary.
- 3. Member District to be named; "Additional Insured;" (this must be stated on insurance certificate).
- 4. User must execute a Hold Harmless Agreement.
- 5. Sports Associations must show evidence that their General Liability Policy will respond to injuries sustained by athletic participants, or show a Certificate of Insurance evidencing an Athletic Participants medical Payments Policy.

Please return your insurance certificate and Hold Harmless Agreement as soon as possible. Without these two requirements, you will not be permitted to use the facilities.
