- 1. I will read part II of this agreement, and will be responsible for obtaining all of the information required by that section and will provide a copy of Part II to the user of this agreement. I will make no misrepresentations to the Adventure Center or to China Peak Mountain Resort, hereafter CPMR, regarding the user's age, height, weight, age, ability, or any other information.
- 2. Participant (and guardian if participant is a minor) is aware that participation in mountain activities generally and particularly THE SPORT OF MOUNTAIN BIKING IN ITS VARIOUS FORMS (including the use of all relative and related equipment, specialized disabled mountain biking equipment, the use of Race Courses, Freestyle Parks, and Terrain Features; any intentional or unintentional jumping at any location; and the use of chairlifts or surface tows) INVOLVES RISKS OF PERSONAL PROPERTY DAMAGE, INJURY, OR DEATH that no amount of care, caution, instruction, or expertise can eliminate. Such dangers include, but are not limited to, variations in terrain and surface conditions, falls, loss of control and collisions with other mountain bikers or with natural and man-made objects. PARTICIPANT FREELY ASSUMES ANY AND ALL RISKS, whether they are marked or unmarked, INCLUDING THE RISK OF ANY NEGLIGENCE OF CPMR.

In addition to the above risks, Participant (and Guardian if Participant is a minor) accepts that SURFACE CONDITIONS on trails, roads, parking lots, walkways, stairs and any other area exposed to the elements of nature are subject to the deposit, melting and refreezing of snow, rain, sleet, hail and ice, and the presence of sand, dust, mud, cinders or gravel, any of which may also be tracked on to interior surfaces, such that WALKING OR OTHER DAILY ACTIVITIES, may become DANGEROUS, particularly in footwear specifically designed for mountain biking and other mountain activities. PARTICIPANT (and Guardian if Participant is a minor) FREELY ASSUMES ANY AND ALL RISKS of all surface conditions, INCLUDING THE RISK OF ANY NEGLIGENCE OF CPMR.

In consideration for being permitted to participate in mountain biking and other mountain activities at CPMR PARTICIPANT (and Guardian if Participant is a minor) AGREES TO FOREVER DISCHARGE AND RELEASE FROM ANY LEGAL LIABILITY AND TO NOT SUE CPMR for any injuries, death, or property damage caused by or resulting from any access to CPMR's premises or participation in any mountain activities, including mountain biking, INCLUDING BUT NOT LIMITED TO INCIDENTS ARISING OUT OF CPMR's ALLEGED NEGLIGENCE.

Participant (and Guardian if Participant is a minor) herby represents they are physically able to participate in mountain activities, including mountain biking, and authorizes any medical treatment deemed necessary in the event of any injury occurring while at CPMR. Participant (and Guardian if Participant is a minor) either has appropriate insurance or, in its absence, agree to pay all costs of rescue and/or medical services as may be incurred on my/our behalf.

7. Participant (and Guardian if Participant is a minor) grants permission to CPMR to use Participant's image appearing in any photographs, videotape, motion picture, or any other media for any of CPMR's advertising or promotional purposes whatsoever, in perpetuity throughout the world.

All bicycles are inspected prior to each rental and immediately following return by CPMR staff.
