Part IV – Description of Activities

The Zonta Club of Saginaw Foundation was organized to receive and administer funds to carryout the charitable objectives of the Zonta Club of Saginaw, including providing service at the local level and to support charitable organizations that advance the charitable objectives of the Zonta Club of Saginaw Foundation.

Local service consists of projects to improve women's legal rights, health, education, economic status, and end violence against women and enhance women's self esteem. Projects have included, mentoring teen mothers participating in the teen parent program at Saginaw County You Protection Council, providing funds for the Sexual Assault Nurse Examiner program of Child & Family service of Saginaw, provide annual scholarship for a young woman in public affairs and provide annual scholarship for a nontraditional woman student. Currently, we are sponsoring two bedrooms at the Underground Railroad, which is a domestic violence shelter. \$5,000 has been provided to the shelter. An additional \$1,500 has been allocated for decorating the two rooms. Members will paint and decorate the rooms, design storage and provide bedding, window coverings and other accessories for the rooms.

At the International level, the foundation will support projects through the Zonta international Foundation. Continuing projects include an Amelia Earhart Scholarship Award, Young Women in Public Affairs Award, Jane M Klausman Women in Business Scholarship and Zonta International Strategies to End Violence against Women Program.

2008-2010 and 2010-2012 international projects include Prevention of Mother-to Child Transmission of HIV in Rwanda, Safe Cities for Women Project in Guatemala City, Guatemala and San Salvador, el Salvador, Reduction of Obstetric Fistula in Liberia within the context of Maternal and Newborn Health, Combating physical violence against women and supporting the implementation of protective and anti-discriminatory laws and policies in Egypt, and Ending Violence Against Women through Community Action (EVAWCA) in Cambodia.

ZONTA CLUB OF SAGINAW FOUNDATION CONFLICT OF INTEREST POLICY

(Adopted March 1, 2011 by the Zonta Club of Saginaw Foundation Board of Directors)

Conflict of interest arises whenever the personal or professional interest of a Board Member is potentially at odds with the best interests of the Zonta Club of Saginaw Foundation. Although the legal standards for avoiding conflict of interest for nonprofit organizations are fairly limited, The Zonta Club of Saginaw Foundation will avoid where possible even the appearance of impropriety.

Under certain circumstances, a contract or transaction between a nonprofit corporation and its director or an organization in which the director has a material financial interest is acceptable. However, if the transaction is challenged, the director will have the burden of establishing that

the contract or transaction was fair and reasonable, that there was full disclosure of the conflict and that the contract or transaction was approved by members or other directors in good faith.

If an issue is to be decided by the Board that involves potential conflict of interest for a Board Member, it is the responsibility of the Board Member to:

- 1. Identify the potential conflict of interest.
- 2. Not participate in discussion of the program or motion being considered.
- 3. Not vote on the issue.

It is the responsibility of the Board to:

- 1. Only decide to hire or contract with the Board member if they are the best qualified individuals available, and willing to provide the goods or services needed at the best price.
- 2. Record in the minutes of the Board Meeting the potential conflict of interest, and the use of the procedures and criteria of this policy.

Qualifications for the scholarship are as follows: minimum 2.0 GPA, Saginaw County resident, Attending Delta College, Davenport University-Central Region or Saginaw Valley State University, non-traditional woman student (out of high school for at least six months with no academic experience or out of college for two consecutive semesters or more before returning to school) and part-/full-time enrollment.

The evaluation criteria (points) are Commitment to career as demonstrated in the essay (30); financial need (20); overall involvement in community, school, and work activities (20); leadership (15); and recommendations (15).
