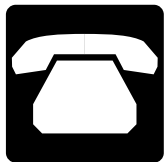
Dial **703-368-9694** from your fax machine to get up to 3 of the following items per call. Follow the directions of the prompts and your items will be faxed back to you.

Obtain forms, publications, instructions and tax assistance by calling:

- **1-800-829-3676** to order current and prior year forms, instructions and publications between 7:00 a.m. and 11:00 p.m. Monday through Saturday (Pacific Standard Time for Alaska and Hawaii, Eastern Standard Time in Puerto Rico). The best time to call is before 9 a.m. or after 2 p.m. Thursdays and Fridays are the best days to call. (You should receive a response within 7 to 15 workdays).

Walk-In

Pick up certain forms, instructions, and publications at many post offices, libraries, and IRS offices. Some libraries and IRS offices have an extensive collection of products available to print from a CD-ROM or photocopy from reproducible proofs.



CD-ROM

Order IRS Publication 1796, *Federal Tax Products on CD-ROM* and obtain:

- Current tax forms, instructions and publications
- Prior-year tax forms and instructions beginning in 1991 and publications from 1994
- Popular tax forms which may be filled-in electronically, then printed out for submission
- Internal Revenue Bulletin

The CD-ROM can be purchased from the Government Printing Office (GPO), Superintendent of Documents for \$20.00 by calling 202-512-1800 (select Option #1) or through GPO's Web Site at http://www.access.gpo.gov/su_docs.

Availability: First release—Early January
Final release—Mid-February
