Release of Liability, Waive of Claims, Assumption of Risk and Indemnity Agreement
PLEASE READ CAREFULLY

Release of Liability, Waiver of Claims and Indemnity Agreement

In consideration of participating in the 'Game', I hereby agree to as follows:

1. **TO WAVE ANY AND ALL CLAIMS** that I have or may have in the future again PRZ Paintball (Picton Recon Zone), their directors, officers, employees, agents, and representatives (all of who are hereinafter collectively referred to as, 'The Releasees') ;
2. **TO RELEASE THE RELEASEES** from any and all liability for any loss, damage, injury or expenses that I may suffer or that my next of kin may suffer as a result of my participation in **Paintball/Airsoft** due to any cause whatsoever, **INLUCDING NEGLIGENCE ON PART OF THE RELEASEES;**
3. **TO HOLD HARMLESS AND INDEMNITY THE RELEASEES** from any and all liability for any damage to the property of, or personal injury to, any third party, resulting from my participation in **Paintball/Airsoft; and**
4. That this agreement shall be effective and binding upon my heirs, next of kin, executors, administrators and assigns, in the event of my death.

Assumption of Risk

- 1) I, the undersigned, wish to play Paintball/Airsoft. I recognize and understand that playing Paintball/Airsoft (hereinafter called the 'Game') involves certain risks. Those risks include, but are not limited to, the risk of injury resulting from possible malfunction of the equipment used in the 'Game' and injuries from tripping or falling over obstacles in the game playing field. In addition, I recognize that the exertion of playing the 'Game' could result in serious injury or death.
- 2) I hereby certify that the equipment used is certified as ballistic and/or at the very least Paintball/Airsoft specific equipment, for the use of, but no limited to, eye protection. I understand full face protection is recommended as the minimum safety protection and I understand sole responsibility to ensure this on myself, the player.
- 3) Despite these and other risks, and full understanding such risks, I wish to play the 'Game' and hereby assume the risks of playing the 'Game'. I also hereby hold harmless the 'Sponsors' and the properties thereof, and indemnify them against any of all claims, actions, suits, procedures, costs, expenses, including, legal fees and expenses, damages and liabilities arising out of, connected with, or resulting from my playing the 'Game', including equipment. I hereby release the Sponsors and the property thereof from any and all such liability, and I understand that this release shall be binding upon my state, my heirs, my representatives and assigns. I hereby certify to the Sponsors that I am in good health and do not suffer from a heart condition of other ailment which could be exacerbated by the exertion involved in playing the 'Game'. I further certify that I am 18 years of age or older. (If under 18 years of age, waiver must be signed by Parent or Guardian)
