

**AGREEMENT, ASSUMPTION OF RISK, AND RELEASE FROM LIABILITY**

I, \_\_\_\_\_, hereby acknowledge that I have voluntarily applied to participate in a parachute jumping/skydiving event called "Jump for Israel," a fundraising effort sponsored by the Zionist Organization of America ("ZOA"). In consideration for being permitted to participate in this event, I hereby agree as follows:

1. Representations and Warranties. I know and understand that the ZOA is sponsoring Jump for Israel to raise money for soldiers in the Israel Defense Forces. If I am permitted to participate in this event, the ZOA will be responsible for scheduling my parachute jump/skydive with an entity that is authorized to engage in these activities (the "Entity"). I know and understand that the ZOA has no control over or responsibility for the parachute/skydiving instruction and training that may be provided, the parachute system, the plane, the jump itself, and/or any of the equipment. I also know and understand that the ZOA makes no representations or warranties with respect to the Entity's parachute/skydiving instruction and training, its equipment, or any other aspect of the jump/skydive. I know and understand that the ZOA and its officers, directors, agents, employees and representatives are not responsible for any errors, omissions, acts, or failures to act by the Entity. \_\_\_\_\_ (Initials)

2. Assumption of Risks. I know and understand that parachute/skydiving instruction, training, and jumping are very dangerous activities and will expose me to the risk of serious personal injury, death and/or property damage. I voluntarily and freely choose to accept these risks. \_\_\_\_\_ (Initials)

3. Agreement to Abide by Rules, Policies and Instructions. I agree to abide by the rules, policies and instructions of the Entity. This includes my agreement to execute any and all forms and documents required by the Entity in contemplation of the jump. \_\_\_\_\_ (Initials)

4. Release from Liability. I, my heirs, next of kin, assigns, distributees, executors, administrators, guardians and legal representatives, hereby exempt, release, discharge, and hold harmless, the ZOA, its officers, directors, agents, representatives, employees, successors and assigns, from any and all liability, claims, demands, actions or causes of action arising directly or indirectly from my participation in Jump for Israel. \_\_\_\_\_ (Initials)

5. Covenant not to Sue. I agree never to institute any suit or action at law or otherwise against the ZOA, its officers, directors, agents, employees or representatives, arising directly or indirectly from my participation in Jump for Israel. \_\_\_\_\_ (Initials)

6. Continuation of Obligations. It is my understanding and intention that this Agreement, Assumption of Risk, and Release from Liability shall be binding on the heirs, executors and administrators of my estate, and on my next of kin, assigns, distributees, guardians and legal representatives. \_\_\_\_\_ (Initials)

7. Damages, Attorneys' Fees and Costs. Should any suit or action at law or otherwise be instituted in violation of this Agreement, Assumption of Risk, and Release from Liability, I, on behalf of myself, my heirs, next of kin, distributees, executors, administrators, guardians, legal representatives and assigns, agree that the ZOA shall be entitled to recover, in addition to any other damages that may be incurred, attorneys' fees and costs incurred in the defense of such action, including any appeals.

8. Certification. I certify that I am at least 18 years old, and that I have not been advised not to participate in Jump for Israel by a qualified medical professional. I also certify that there are no health-related reasons or problems that might preclude my participation in Jump for Israel.

9. Headings. I agree that the headings and subheadings used throughout this Agreement, Assumption of Risk, and Release from Liability are for convenience only and have no significance in the interpretation of this Agreement, Assumption of Risk, and Release from Liability.

10. Interpretation of Terms. I acknowledge and agree that this Agreement, Assumption of Risk and Release from Liability is intended to be as broad and inclusive as is permitted by law, and that if any portion of it is held invalid, the remainder shall continue in full force and effect.
