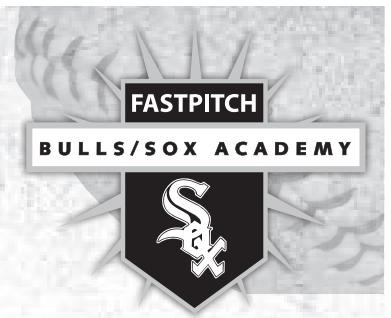


FASTPITCH SOFTBALL PROSPECT CAMP



This is your opportunity to showcase your fastpitch skills in front of college coaches across the Midwest! All players will be tested for leg speed, bat speed and arm speed. Each coach will receive a "Prospect" handbook that will include a player profile for each participant. On Saturday, prospects will showcase their talents by position for a host of college coaches from Division I, II, III, NAIA and NJCAA schools. This is not your ordinary exposure camp! We run players through a series of position specific drills, along with taking a full (60ft.) infield, so that you can showcase the following skills:

- Arm Strength and Accuracy
- Glove Work
- Peer Interaction
- Agility and Leg Speed
- Foot Work
- Concentration
- Lateral Movement
- Communication

All players and parents will participate in a one hour recruiting seminar. This is your opportunity to ask any recruiting questions you may have.

WAIVER AND GENERAL RELEASE AND COVENANT NOT TO SUE:
