Rules and regulations governing the 2014 7th Annual Mile High Select Quarter & Paint Horse Sale, January 11, 2014, Denver, CO. <u>Before signing please read carefully.</u>

The sale will consist of 50 Registered Quarter Horses and 50 Registered Paint Horses two and older. FOALS OF 2013 WILL NOT BE ACCEPTED. Title to each animal must be free from all adverse claims to ownership. All entries must be accompanied by a copy of the registration papers, footnotes, current photos and or videos. Consignor understands that with the submissions of this form, related paperwork and fees, constitutes only a "nomination" and the nominated horse does not become a consignment until fully accepted in writing by Sale Management. All entries will be screened by photos, videos, pedigrees, training, official show records or live inspection. Consignor will be notified of the acceptance or rejection of entries on or before December 15, 2013. If the entry is sifted, an office charge of \$25.00 per horse will be charged and the balance of the entry fee will be refunded.

An entry fee of \$275.00 per horse, for 1 to 2 horses, if a consignor has 3 or more horses the entry fee will be \$250 per horse (AQHA or APHA and owned by the same consignor), registration papers, signed transfers, current photos and/or a video must accompany entry. Include a check for the total entry fee per horse, made out to RMQHA.

8% of the final recognized bid will be deducted from sale proceeds. The highest bidder is to be the buyer. If the bid is not suitable to the consignor, the consignor must have the last bid. A buyer's number will be included in your packet for this purpose. If you, the consignor, are the last bidder, you will be charged 8% or \$100 of the last bid, whichever is greater. If an entry is withdrawn before acceptance all but \$25.00 of the entry fee will be refunded. If an entry is withdrawn after acceptance there will be no refunds on entry fees. If an entry is withdrawn after the catalog is printed a fee of \$500.00 in addition to the entry fee will be charged before registration papers are released unless entry is withdrawn because of illness or injury that must be verified by letter from the attending veterinarian. All horses arriving on the sale premises must enter the sale ring unless excused by the sale Veterinarian or dismissed by the sale committee. This sale is a select sale. All sale horses shall be in top condition with acceptable hair coats. If entry arrives at the sale in an unfit for sale condition by decision of the sale committee, they will be excused from the sale and no entry fees will be refunded.

Consignors are responsible for the presentation of their horse. In the event of an unsafe situation, there will be 1 sale steward available.

All Consignors must be current (2014) members of either the Rocky Mountain Quarter Horse Association or the Rocky Mountain Paint Horse Association. If you are not a current member, please submit a check with the entry to the applicable association (payable to each association):

All horses delivered to the Sale Facility must comply with the health requirement of the Department of Agriculture of the State of Colorado including a <u>current Coggins test (within 1 year of sale date)</u> and a Certificate of Vet Inspection dated within 30 days of the sale date. Separate and original Coggins Reports and Certificate of Vet Inspection will be required on each horse. Consignor must also have a current brand inspection on horses coming from areas or states where same is required.

Stalls will be furnished and pre-assigned. There will be no switching of Stalls. Please check the wall for your assigned stall. Consignors must furnish their own feed and care for each horse until sold. Bedding must be purchased from the National Western Stock Show concessionaire.

<u>All responsibilities and guarantees lie solely between Buyer and Consignor</u>. Except as otherwise announced by the announcer at the time of sale, the Consignor represents and warrants unto Buyer as follows: (1) The horse is sound of eyes, wind, and limb, (2) the horse is not a "cribber", (3) the horse has not been nerved or does not express navicular tendencies, (4) the sex or condition of a gelding or ridgeling is as described in the catalog, and (5) a colt or stallion at least 18 months of age does possess, at the time of the sale, two testes descended to the scrotum. If the horse has any of the above-described defects the consignor must advise the Sales Management so that the proper announcement can be made while the horse is in the auction ring. The entire auction will be recorded on tape.

Consignor hereby grants permission to prospective buyer, at his or her own expense, to have an accredited veterinarian perform an inspection of consignment prior to the sale.

Broodmares must be pregnancy tested within 10 days of sale date with the results presented, in writing, to Sales Management upon arrival at sale grounds. Any purchaser of a broodmare sold in this sale may have her examined within 24 hours after the fall of the hammer and prior to the removal from sales premises, by a Veterinarian acceptable to the undersigned. Any broodmare so examined whose pregnancy or breeding soundness status is found not to be as represented at the time of sale may be returned to consignor as unsold and the consignor shall pay the veterinarian's fee for examination. A valid breeder's certificate for mares in foal is required prior to the sale date.

In the event a Buyer fails to pay for or accept a horse, the sale committee reserves the right to accept the same purchase amount from another person, accept the next highest bid, put the horse up for sale a second time, or retain it for the Consignor as unsold. The Rocky Mountain Quarter Horse Association, the Rocky Mountain Paint Horse Association, the National Western Stock Show Association and representatives, thereof, shall not be liable for any deficit should the final bid or price on resale be less than the initial sale. In any case, where an animal is not paid for fully in cash and/or check (including without limitation, refusal to pay, stoppage of payment of check or draft, return check or draft marked "Insufficient Funds", or "no account" or the like), or should conditions make immediate resale herein provided impossible or impractical, Consignor agrees to receive the animal back as unsold, without any liability to the Rocky Mountain Quarter Horse Association, the Rocky Mountain Paint Horse Association, the National Western Stock Show Association and representatives, thereof.

The RMQHA and RMPHA will use reasonable efforts to verify the financial responsibility of the buyer of each animal and that possession of each animal sold will be released to the buyer against receipt of future payment after satisfaction of settlement procedures. Rocky Mountain Quarter Horse Association, Rocky Mountain Paint Horse Association, and the National Western Stock Show Association will not be liable for the purchase price of an animal if buyer defaults.

Consignor agrees to hold harmless and indemnify Rocky Mountain Quarter Horse Association, Rocky Mountain Paint Horse Association, and National Western Stock Show Association, it's agents or employees from and against any and all liability, debts, claims, suits, losses, damages, causes of action, judgments, costs and expenses, including attorney's fees arising or allegedly arising from personal injury or death of any person or horse, out of the Consignors use of any of the facilities in connection with the Consignors sale due in any manner to the negligence or intentional acts of the Consignor, any of its employees, agents or servants in the performance of the Consignors sale or any act, error, omission or negligence of RMQHA and RMPHA occurring concurrently with that of the Consignor or contributing to any loss indemnified hereunder, except for the sole negligence or willful misconduct of the RMQHA and RMPHA. Consignor agrees to the terms and Sale Conditions and Settlement Procedures published in the sale catalog.

Under Colorado Law, an equine professional is not liable for an injury to or the death of a participant in equine activities resulting from the inherent risks of equine activities, pursuant to section 13-21-119, Colorado Revised Statutes.
