1. Geographic County Code

o Community Program Servicing Office -- Enter the five digit "RDA" mail code of the office that services Community Program (formerly RDA) borrowers in this geographic county. The last three digits will be in the series 701-799.

o Multiple Family Housing Offices -- Enter the five digit mail code of the office servicing Multiple Family Housing borrowers in this geographic county. Any valid Rural Development office type can be indicated in the last three digits of this code.
