## PARENTS CONTRACT DISCIPLINARY ACTION AGREEMENT

All parents <u>must abide</u> to this contract or will not be able to participate in KAC. This will be the Board's way of having each participant understand the Disciplinary Action set forth by the Board.

Coaches, spectators or players who engage in unsportsmanlike conduct, such as, but not limited to, fighting, abusive language, violent displays of temper or similarly derogatory activity, will be subject to action by the Executive Committee.

- A. The Executive Committee shall have the authority to suspend, discharge or otherwise discipline any player, coach, parent, spectator, umpire, referee or any person whose conduct is considered contradictory and detrimental to the values and best interest of KAC.
  - 1. Persons subject to such discipline shall have the right to a hearing before the Executive Committee before such discipline is imposed.
  - 2. In the event of disciplinary procedures involving a person under the age of 18, that person's parents are asked to attend the hearing with the individual concerned.
- B. Recognizing the difficulty of establishing specific penalties for a variety of violations of acceptable conduct, the following penalties are suggested. The Executive Committee may impose any which, in its opinion, matches the severity of the offense:
  - 1. <u>WARNING</u>: The offending person is to be advised in writing of the offense, and further advised that repetition of the offense will result in a more severe penalty.
  - 2. <u>SUSPENSION</u>: The offending person is to be advised in writing that s/he has been suspended from all league activity for a specific number of days or games.
  - 3. <u>DISMISSAL</u>: The offending person is to be advised in writing that s/he has been dismissed from the league for the remainder of the current year or more.
  - 4. **BARRED**: The offending person is to be informed in writing that s/he has been barred from present and future participation in the league permanently or for a specific number of years.
