Application Process

Application: The fee to process your application is **\$35.00** cash or money order Per Adult. Please allow 3 business days to process your application. This may vary depending on the timeliness of responses from previous landlords and/or current employers. While your application is processed, the property applied for will remain on the available list until you are approved and have placed a deposit.

Deposit: Once notified of your application approval you will be asked to place your security deposit which is equivalent to one month's rent amount. The security deposit MUST BE IN THE FORM OF A MONEY ORDER OR CASHIER'S CHECK. Please <u>do not</u> include rent monies with your security deposit.

Rent: Once you have placed your security deposit, Metric Realty Company will place a 15 day hold on your property. Your first month's rent or pro-rated amount is due on the day you pick up the keys. Please ask concerning pet size limits on each property.

Approval Criteria

Rental History:

No more than 2 late payments for any 12 month period.

Income:

Rent cannot exceed 40 percent of gross monthly income.

Credit Report:

No debt can be owed to any landlord, management company, apartment community, etc.

Evictions:

No evictions in the last 2 years.

Criminal Record:

No convictions of any felony within the last 3 years.

No more than 2 arrests within the last 5 years.

No arrests or convictions for sexual related offenses.

Pet Policy:

Due to the nature of the breed, Metric Realty Company <u>does not</u> accept Rottweilers, Pitbulls, Chows, German Shephards, Doberman Pinchers, Presna Canarios or any mix of these breeds. An additional \$400.00 non-refundable pet deposit **per pet** is required of those with pets and there is a monthly pet fee of \$20 in addition to the rent. Please ask concerning pet requirements on each property.

Co-Signers:

We do accept applications from prospective tenants who have no previous rental history or have marks on their credit report which can be explained. If this is the case, it may be necessary to use a co-signer. The co-signer must meet the rental criteria perfectly. They will be screened just as an applicant and must sign the lease agreement.
