

# **Basic Food Employment & Training Program (BFET)**

### What is BFET?

YVCC's Basic Food, Employment and Training Program (BFET) provides services to Basic Food *(Food Stamp)* recipients in Washington State. Services may include establishing or maintaining eligibility for Basic Food while in school, child care subsidy, job search and job search training and other support services.

### **BFET Provides:**

- Eligibility for Working Connections Child Care through Department of Social and Health Services(DSHS)
- Eligibility to receive Basic Food Benefits (Food Stamps) while enrolled in college
- Financial assistance with college related expenses
- Support Services

### **Eligibility Requirements:**

- Receiving or eligible to receive Basic Food Benefits (Food Stamps)
- Eligibility is based on household income at or below 200% of the federal poverty rate see below
- You <u>must not</u> be receiving Temporary Assistance for Needy Families (TANF)
- You must be a US Citizen, Refugee, or Immigrant (*that has been in the United States more than 5 years*)
- You must be enrolled in a Professional/Technical program or in an ESL, ABE or GED program (*Transfer degree programs are not eligible*)
