- 1. There will be a 60-minute time limit on all games (unless tied). Games do not have to go seven (7) innings. Ties will be broken by "One-Pitch" at the end of the 60 minute time mark (even Championship games).
- 2. A coin flip will be used for all games to determine home team.
- 3. Slaughter Rule: 15 after four innings or 10 runs after five (5) innings.
- 4. NO GRACE TIME; There will be no grace period for all games. Teams must field at least 8 players in Men's play (9 players for CoRec) from the scheduled starting time.
- 5. The Home Team for each game must provide an official scorekeeper.

6. MCR will supply two new softballs that are 52-core/300 for Men and .44-core/375 compressions for women per game. Back-up balls must have an ASA stamp on the ball. Teams will provide back-up ball(s). Team putting the ball out-of-play is responsible for replacing the ball.

- 10. Home run: Men's "C" 5 per team per game, and "C/D", "D" and "CoRec" home run limit of 3 per team per game. The one-up rule will NOT apply.
