Parking Lot Side

1. The awning should have a matte finish, black material.
2. Remove the existing sign from the fascia above the original storefront.
3. Remove the paper signs and the animated 'Open' sign from the window. Keep the 'Piccolo' on the glass.

Street Side

- 1, Keep the existing awning framework that is centered over the two business entrances, and provide new matte finish awning material in black over the Piccolo door, and purple over the Pilates entrance door. This will be similar to the awning on the parking lot side.
2. Remove the existing awning with the name Piccolo which is located above the window of the original storefront.
3. Provide a hanging sign mounted perpendicular to the street at the junction of the existing and new space. The hanging sign shall meet the Ridgefield sign regulation requirements.

COMMENTS, EXCEPTIONS AND/OR RECOMMENDED CONDITIONS

The AAC commends the concept of this memorial, and offers the following recommendations:

1. The memorial section of steel should be as tall as possible, and set on a concrete pedestal to add to the overall height. Concrete is indicative of one of the basic materials of the WTC.
2. Simplify the planting scheme. There should be five significant trees radiating from the five points of the Pentagon paving design.
3. The base of the sculpture should be planted with a bed of boxwood, which extends out from the base of the sculpture about 6' or so.
4. The AAC does not think a walkway to the sculpture from the existing path is necessary. The area between the sculpture and the trees should all be lawn.
5. Benches proposed for the site should just be blocks of granite, no backs.

We look forward to seeing the revised design of this important memorial.
