D. Masters stated some publicity would be helpful to explain the grant money won't be ours unless the voters approve it at referendum. J. Plock suggested putting up explanatory posters as in the past; however, R. Marconi stated that if we were to do this, the same information must be provided in all absentee ballots. D. Masters suggested articles in the local papers as well as posting the info on the Town website.
