Free Access for County (and Regional) Sportspeople

What is FACS

The Kent FACS scheme has been established to provide support to Kent's leading talented sports performers. The scheme aims to provide county level sportspeople with free access at designated off-peak times to a number of the County's leisure and sports facilities for personal training and development.

The Kent FACS scheme is run by individual local authorities in Kent and has the full support of Kent Sport, Leisure & Olympics Service.

The scheme is an extension to the Kent FANS Scheme and offers county and regional level sportspeople access to sport and leisure facilities within the local authority that they pay their council tax. It provides opportunities for sportswomen and sportsmen of all ages, including those with disabilities, who currently perform or compete at a county or regional level and reside for the majority of the year in Kent, excluding the London boroughs - Bromley, Bexley, Greenwich and Lewisham.

Eligibility

- County or Regional representative
- Part of a County or Regional training/ coaching squad
- Successful in any County or Regional age group competition (top 10 finish) in the last 12 months

Evidence or confirmation of a performer's involvement at a county or regional level will be required from the appropriate governing body of sport.

Operational Guidelines

Each FACS member will be entitled to free training at the facilities in the local authority they pay their council tax, during designated off-peak times, when the facilities are open, providing there is no disruption to other users and no additional cost is incurred by the facility, eg. floodlighting.

Kent FACS members will be able to use facilities officially registered within the County wide scheme.

A list of facilities within each local authority is available from the local authority sports development unit or Kent Sport, Leisure & Olympics Service.

Membership of the Kent FACS scheme is renewable every 12 months pending continued sports performance at a county or regional level. It is the reponsibility of the performer to request renewal of membership.

FACS members will be allowed one free training partner if the sport so requires and/or a personal coach, if appropriate.

In return for FACS membership, a condition specifies that, within reason they will make every effort to attend promotional events as requested by any of the participating facilities within their local authority.

The local authority reserves the right to withdraw membership if the FACS scheme is abused in any way.
