WHAT IS APPA?

The American Public Power Association represents not-for-profit, community-owned electric utilities that power homes, businesses and streets in nearly 2,000 towns and cities, serving 47 million Americans. WHY SHOULD I CARE ABOUT PUBLIC POWER UTILITIES?

- public power utilities account for almost 15% of the electric utility industry's revenues
- public power entities serve 47 million people and 2.8 million commercial and industrial customers
- public power utilities sell almost 571 million megawatt hours (MWh) of electricity, about 15.4% of the 3.7 billion MWh sold total
- public power entities own more than 120,000 megawatts of generation capacity, almost 10% of the total of MWh in the entire U.S.
- ninety-seven of the nation's 100 largest public power utilities are APPA members
- forty-nine states have public power utilities (only Hawaii does not)

HOW MUCH ARE CORPORATE ASSOCIATE DUES?

Annual dues are \$3,000. Companies that meet small business eligibility requirements under federal Small Business Administration guidelines are eligible for a 50% discount (\$1,500 annually). Applicants in the small business category are responsible for determining and proving eligibility according to federal Small Business Administration standards (sba.gov) and must provide the NAISC or SIC code under which they're claiming eligibility on the corporate associate membership application.
