



General information

Sportspersons who are competing for prize money, and Professional Entertainers, may be eligible for assistance on the freight paid for transporting the equipment that they use for these activities.

For the purposes of the scheme

Sportspersons must be competing in a sporting event where prize money is paid. However, as prizes, rewards and income vary according to the type of show or sporting event, eligibility will be decided on a case by case basis.

Professional entertainers must receive an income, fee or financial reward from performing in a show or event. In determining eligibility, consideration will be given to whether entertainment is their occupation or main source of income, and whether entertainment is the primary purpose of the trip.

Equipment includes all things used directly in the entertainment or sporting events (e.g. sideshow equipment, sound equipment, sports cars etc). It does not include living accommodation, personal vehicles* etc.

The cost of shipping equipment must be incurred by the sportsperson or professional entertainer, or their talent manager.

* **NOTE:** Accompanied passenger vehicles attract assistance through the Bass Strait Passenger Vehicle Equalisation Scheme.

Assistance available

The amount of assistance paid to the entertainer/sportsperson is calculated on the basis of a twenty foot unit (TEU) equivalent. Details of the methodology for calculating assistance under the Tasmanian Freight Equalisation Scheme can be found in the Ministerial Directions for the scheme.

Documentary requirements

The following documentation must be sent in with your completed 'Sportsperson's and Professional Entertainer's Declaration' (on page 2):

- a completed **Tasmanian Freight Equalisation Scheme Claim for Assistance** form (**TAS002**),
- original invoices and copies of consignment notes for both legs of the round trip, **and**
- a completed **Tasmanian Freight Equalisation Scheme Cargo and Trailer Dimensions** form (**TAS016**) detailing the configuration and the dimensions of the equipment shipped.

Freight costs must be paid before making a claim.
