

SPRING 2014 HAZMAT TRAINING SEMINAR

As stated under **IMDG Code Chapter 1.3** and **49 CFR 172 Subpart H**, employers are required to provide training to **all** personnel who handle or are otherwise involved with the transportation of hazardous materials including the documentation for the materials. The regulation requires recertification every three years. If you have not had this training, or need re-certification, be sure to register now.
